REASONS FOR DECISION TO DISMISS OBJECTION APPLICATIONS

Background

- [1] On the dates set out in the attached schedule, the Government party gave notice under s 29 of the *Native Title Act 1993* (Cth) of its intention to grant the listed exploration licenses and included in the notice a statement that it considered that the grants attracted the expedited procedure.
