SCHEDULE A: NATIVE TITLE CLAIM GROUP

The names of the persons (the native title claim group) on whose behalf the application is made or a sufficiently clear description of the persons so that it can be ascertained whether any particular person is one of those people.

- 1. The native title claim group ("the claimants") in relation to the area claimed is comprised of the Primary Native Title Holders and Other Native Title Holders who, according to traditional laws acknowledged, and customs observed:
 - (a) are traditionally connected with the area described in schedule B ("the area claimed") by reason of:
 - (i) patrilineal descent;
 - (ii) his or her mother, father's mother or mother's mother being or having been a member of the group by reason of patrilineal descent; or
 - (iii) having been adopted or incorporated into the descent relationships referred to in (a) or (b) hereof; and
 - (b) have a communal native title in the application area, from which rights and interests derive.
- 2. The Primary Native Title Holders by definition in relation to the area claimed are comprised of eight estate groups:
 - (a) Guyal Manaburru estate group;
 - (b) Burdal Mingkanyi estate group;
 - (c) Burdal Riley estate group;
 - (d) Murrungun Wunubari estate group;
 - (e) Murrungun Baluganda/Langgabany estate group;
 - (f) Mambali Walangara estate group;
 - (g) Mambali Ngubayin estate group; and
 - (h) Mambali Nangguya estate group.



Guyal Manaburru estate group

- 3. By definition the Guyal Manaburru estate group is comprised by persons descended from two deceased apical persons being Larry Dingdji Mumatji and Sandy O'Keefe.
- 4. The descendants from Larry Dingdji Mumatji include:
 - (a) Bruce Kulkulmirri (deceased) who had no children:
 - (b) Bruce Limmen (deceased) who had the children Mary Limmen and Tom Hume;
 - (c) Girly Limmen (deceased) who had the children Sammy, Gerald, Marie and Noel Limmen (all deceased), Mavis, Julie and Nelson Limmen.
- 5. The descendants from Sandy O'Keefe include Kathleen Limmen (deceased) who had a daughter Dulcie Hogan.

Burdal Mingkanyi estate group

- 6. By definition the Burdal Mingkanyi estate group is comprised by persons descended from one apical person being Tonson Roberts Murladji.
- 7. The descendants from Tonson Roberts Murladji include:
 - (a) George Tonson (deceased) who was an Aboriginal man who had the children Leanne, Damien, Tina and Freddie Tonson;
 - (b) Dotty Tonson (deceased) who was an Aboriginal woman who had no children.

Burdal Riley estate group

- 8. By definition the Burdal Riley estate group is comprised by persons descended from three deceased apical persons being Wulwanggu, Ruluju and an unnamed man.
- 9. The descendants from Wulwanggu include Niyundiyege (deceased) who had the children George Riley Marlindja, Mac Riley Manguji, William Riley Nambayala and Tom Riley Nawurrungu (all deceased).
- 10. The descendants from Ruluju (deceased) include Larry Riley Buruwulanji (deceased) who had the children Paddy Riley Wurrandan, Ginger Riley Munduwalawala, Robert Riley Manjayu, Roy Hammer Gundunguwu and William Riley Jarrbulangayi (all deceased).
- 11. The descendants from the unnamed man include Barragaga (deceased) who had the children Cyril Burranda and Sandy August Liwiliwirri (both deceased).

Murrungun Wunubari estate group



- 12. By definition the Murrungun Wunubari estate group is comprised by persons descended from five deceased apical persons being Janggawuma, George Marindilama, Gabarunguna, Long Jack Majala and an unnamed man.
- 13. The descendants from Janggawuma include:
 - (a) Clara (deceased), who had the children Harriet Mambuwarrga, Simon Bawujiminja, Dima, Damburru and Juri (all deceased);
 - (b) John Forrest Bunuji (deceased) who had the children Elsie Forrest Manbiliyungu, Queenie Riley Nambarrurludi, Freda John Forrest Miramba, Tex John Forrest Walayanggayangga (all deceased) and Gordon Forrest Nawundulpi.
- 14. The descendants from George Marindilama include:
 - (a) Gulumba (deceased) who had the children Stanley Mabungu, Andai Mawurranja and Nora Walingandu (all deceased);
 - (b) Windjimalgu (deceased) who had no children;
 - (c) Harry Limmen (deceased) who had the children Sammy, Gerald, Marie and Noel Limmen (all deceased) and Mavis, Julie and Nelson Limmen.
- 15. The descendants from Gabarunguna include Jack Baju (deceased) who had the children Jemima Wiyumarlu, Musso Harvey Bunggarinu, Jack Isaac Yuwalinji, Elsie Marawayulu, Jack Douglas Wadaba, Andrea Mulholland Maliyawuna and Mulgin Malcolm Majamaja (all deceased).
- 16. The descendants from Long Jack Majala include:
 - (a) Rosalyn Roberts Mawurarila (deceased) who had a daughter Jennifer Roberts;
 - (b) Edna Pluto Maliyawuna (deceased) who had the children Timothy and Bob Pluto (both deceased), Ivan, Douglas, John, Dixie and Patsy Pluto;
 - (c) Malcolm (deceased) who had no children;
 - (d) Eileen Milbirriya (deceased) who had no children.
- 17. The descendants from the unnamed man include:
 - (a) Mirrinmirrin (deceased) who had a son Albert Lindarrangu (deceased);
 - (b) Wangiwangi (deceased) who had the children Joshua Ambirrirring and Isaac Joshua Loburr (both deceased).

Murrungun Baluganda/Langgabany estate group



- 18. By definition the Murrungun Baluganda/Langgabany estate group is comprised by persons descended from three deceased apical ancestors being Sandy/Barney Namayinbarra, Alice Jackson Minggangu and Lansen Jackson Jijanyuwularra.
- 19. The descendants from Sandy/Barney Namayinbarra include:
 - (a) McIntyre Gudang (deceased) who had no children;
 - (b) Clara Roberts Ngariji (deceased) who had the children George Tonson Wandirmumu, Dotty Tonson (both deceased) and Helena Dashwood;
 - (c) Jessie August Wuldu (deceased) who had the children Billy Fulton (deceased), Vincent Fulton, Lesley and Stephen August and May Sandy.
- 20. The descendants from Alice Jackson Minggangu include Johnson Gibbs (deceased) who had no children.
- 21. The descendants from Lansen Jackson Jijanyuwularra include:
 - (a) Pansy Ngariji (deceased) who had the children Roseanne, Phillip and Gary Robertson (all deceased) and Andrew, Charlie, Erica and Brian Robertson and Margaret, Stewart and Lesley Hall;
 - (b) Peter Jackson Lansen Barlmindala (deceased) who had the children Peter Lansen Gudang, Andrew, Sabina, Cecilia and Errol (deceased) Lansen;
 - (c) Maurice Lansen Mujumuju (deceased) who had the children Kevin (deceased), Maria, Joanne and Desley Lansen.

Mambali Walangara estate group

- 22. By definition the Mambali Walangara estate group is comprised by persons descended from two deceased apical persons being Wuwandaya and an unnamed man.
- 23. The descendants from Wuwandaya include:
 - (a) Ganjirrwala (deceased) whose children include Joe Yabumana, Peter Ngarrawu and Topsy Mindirriju (all deceased), Fanny Yilayi and Henry Jurluba;
 - (b) Mawurlu (deceased) who had a daughter Bessie Wunyuga (deceased);
 - (c) Jujuju Gurrunangul (deceased) who had a son Barney Marrambamu (deceased);
 - (d) Wurranduwa (deceased) who had the children Roger Rogers Ganbubuk, Queenie Simon Anjarlarla and Rosie Yungarnanji (all deceased).
- 24. The descendants from the unnamed man include:
 - (a) Guywiyarru (deceased) who had a son Daniel Guralduwa (deceased);



- (b) Kitty Gunjurli (deceased) who had the children Girly Limmen and Bruce Limmen (both deceased);
- (c) Bilbajarrminy (deceased) who had the daughter Maliyawuru Jilriba (deceased).

Mambali Ngubayin estate group

- 25. By definition the Mambali Ngubayin estate group is comprised by persons descended from four deceased apical persons being Frank Dangkala Whitefoot, Lucy Nangguya Guduwarru, Hughie Watson Manungu and Gilbert Jandayi Malanggarna.
- 26. The descendants from Frank Dangkala Whitefoot include:
 - (a) Beetaloo Tom/Lefthand Tommy Kurajida (deceased) who had the children Robert and Michelle Ellis;
 - (b) Beetaloo John Kajida (deceased) who had the children Shirley John Jawngali (deceased), Barbara John Yabulwarri, David John Dangkala Yijangmaban and William John Malanggarna;
 - (c) Yama/Buwanjana (deceased) who had a son, Frank Jackson (deceased);
 - (d) Lena Yabulwarri (deceased) who had a son, Dicky Miller/Rogers Wulgundumaji;
 - (e) Kathleen Ngagburri (deceased) who had no children;
 - (f) Mayarranma (deceased) who had no children.
- 27. The descendants from Lucy Nangguya Guduwarru include Sandy August Liwiwiliwirri (deceased) had the children Billy Fulton (deceased), Vincent Fulton Kangili, Stephen August, Lesley August and May Sandy.
- 28. The descendants from Hughie Watson Manungu include:
 - (a) Phillip Watson Gabarlama who had the children Vanessa, Anthea, Anton, Warwick, Timmy and Joe Watson;
 - (b) Alan Watson Yarradanguna who had the children Delaneon and Felicia Watson;
 - (c) Rhonda Watson who had the children Thomas, Renita, Larissa and Abril;
 - (d) Rhoda Watson who had no children:
 - (e) Dennis Watson Mambalayarra who had the children Dougie, Reggie, Mark and Denise Watson;
 - (f) Glen Watson Biyaji who had no children;



- (g) Lena Watson who has the children Altina, Ryona, Katrina, Valerie, Trent, Abel and Thomasina.
- 29. The descendants from Gilbert Jandayi Malanggarna include Stephen August who has children.

Mambali Nangguya estate group

- 30. By definition the Mambali Nangguya estate group is comprised by persons descended from four deceased apical persons being Lame Jack, Iffly Johnny, Manyangarabi and Tjibanme.
- 31. The descendants from Lame Jack include:
 - (a) Alice Douglas (deceased) who had the children Herbert, Ted, Henry, Nuna, Lyla, Neil, Mamie and Peggy Walden (all deceased);
 - (b) Jacko Douglas (deceased) who had the children David, Rachel, Kathleen and Violet Douglas (all deceased) and Irene Douglas;
 - (c) Jackie Douglas (deceased) who had no children;
 - (d) Nancy Douglas (deceased) who had a daughter Connie Douglas.
- 32. The descendants from Iffly Johnny include:
 - (a) John Johnny (deceased) who had the children Logan, Irene, Veronica, Trevor and Warren Johnny (all deceased) and Michael, Barry and Karen Johnny;
 - (b) Roy Johnny (deceased) had the children Patsy, Gloria, Glenda, Lance, Leo, Rosemary and Everyl Johnny;
 - (c) Reg Johnny (deceased) who had the children Dale, Herbert, Linden and Kay Johnny (all deceased), Gloria Friday and Deborah Johnny;
 - (d) Amelia Booth (deceased) who had the children Gloria, Melba, Desmond and Thomas Booth and an unnamed daughter (all deceased), and Maurice, Kalvin, Desley, Kathy and Lisa Booth;
 - (e) Kelly Martin who had the children Eddie and David Norman and two unnamed sons (all deceased);
 - (f) Norman Martin (deceased) who had the children Rhonda, Michael, Andrew, Thomas, Norman and Doris Martin.
- 33. The descendants from Manyangarabi include:
 - (a) Bobby Lansen (deceased) who had no children;



- (b) Kitty Gunjuli (deceased) who had the children Bruce and Girly Limmen and Bruce Kulkulmirri (all deceased);
- (c) Mudungguna Old Lansen (deceased) who had the children Harold and Harry Lansen (both deceased);
- (d) Rita Lansen Junbalima (deceased) who had a daughter Kathleen Limmen (deceased);
- (e) Eileen Lansen Mabunjina (deceased) who had no children;
- (f) Nancy Lansen Warakinta (deceased) who had the children Tommy Dodd, Johnny Ah Won, Margaret Lujumbina and Sweeney Swanson (all deceased);
- (g) Peter Lansen Madjagumaji (deceased) who had the children Susan and Jacob Lansen (both deceased), Gwen, Mercy, Valerie and Ronnie Lansen;
- (h) Miyungula (deceased) who had the children Roderick, Hughie, Ned, Edgar and an unnamed daughter (all deceased).
- 34. The descendants from Tjibanme include:
 - (a) Pompey Jack Wanbiyaji Jidalyi (deceased) who had the children Jingle Kidjinmarra and May Lansen Dingle (both deceased) and Lila and Marcus Lansen:
 - (b) Tyson Lansen Gurangudji (deceased) who had the children Lucy Nangguya, Juliet Miller (both deceased) and Noreen Raggett;
 - (c) Mabel Lansen Kalambuna (deceased) who had a son Percy Yum (deceased);
 - (d) Horace Anderson Bilimadji (deceased) who had the children Marie, Tex, Gordon, Rebecca and Dickie Anderson (all deceased) and Jerry, Margaret, Elizabeth and Richard Anderson;
 - (e) Timothy Shaw (deceased) who had the children Geoff, Barbara and Timothy Shaw Jnr;
 - (f) Nelson Yewimadji (deceased) who had the children Kevin, Eric and Cyclone Ward and Janie Wickham (all deceased) and Ivy Willy and Alan Ward.
- 35. The other Native Title Holders in relation to the area claimed are, in accordance with traditional laws and customs, other Aboriginal people who have rights and interests in respect of the determination area, subject to the rights and interests of the estate group members, such people being:
 - (a) members of estate groups from neighbouring estates; and
 - (b) spouses of the estate group members.
