Persons claiming to hold native title:

1. The native title claim group in relation to the claim area described in Schedule B (the application

area) is comprised of the Primary Native Title Holders and the Other Native Title Holders.

- 2. The Primary Native Title Holders are those groups who, in accordance with their traditional laws and customs, have a connection with the land and waters of the application area; and who hold communal native title in this application area, from which rights and interests derive.
- 3. The Primary Native Title Holders are:
- (a) The Indjalandji-Dhidhanu People;
- (b) The Wudawu estate group;
- (c) The Gulanguru estate group;
- (d) The Ilperrelhelam estate group; and
- (e) The Kuntapulangu estate group.
- 4. The Indjalandji-Dhidhanu People are those persons who are:
- (a) Descended from any of the following ancestors:
- (i) Idava, including through his son Dijeru:
- (ii) Kaduka (also known as Annie), including through her son Frank Monkhouse; or
- (iii) Georgina Jackson and her partner Burketown Willy, including through their son Tom Fraser; or
- (b) Recruited by adoption in accordance with the traditional laws and customs of the Indjalandji-Dhidhanu People.
- 5. The Wudawu estate group is comprised of those persons:
- (a) Who are patrilineal descendants of any of the following ancestors:
- (i) Mick Butcher; or
- (ii) Paddy Woodman; or
- (b) Whose mother or father's mother or mother's mother is or was a patrilineal descendant of the ancestors listed at (a) above; or
- (c) Who have been adopted or incorporated into the descent based relationships referred to in (a) and (b) above in accordance with the traditional laws and customs of the Wudawu estate group; or
- (d) Who are accepted as members of the Wudawu estate group by the senior descent based members of the group on the basis of non-descent based connections, including their:
- (i) Birthplace and conception sites;
- (ii) Acquisition of ceremonial and ritual knowledge;
- (iii) Long term residence and historical associate with the area;
- (iv) Seniority in traditional matters concerning the Wudawu estate;
- (v) Kinship ties;
- (vi) Shared subsection and/or moiety affiliation; and
- (vii) Responsibility for shared Dreaming tracks and/or sacred sites connected with the area.
- 6. The Gulanguru estate group is comprised of those persons:
- (a) Who are patrilineal descendants of the ancestor known as King Victor, including through his adopted sons Chuckler, Roy Cummings (also known as Roy Prince) and Prince (also known as Prince Alexander); or
- (b) Whose mother or father's mother or mother's mother is or was a patrilineal descendant of the ancestors listed at (a) above; or
- (c) Who have been adopted or incorporated into the descent based relationships referred to in (a) and (b) above in accordance with the traditional laws and customs of the Gulanguru estate group; or
- (d) Who are accepted as members of the Gulanguru estate group by the senior descent based members of the group on the basis of non-descent based connections, including their:
- (i) Birthplace and conception sites;
- (ii) Acquisition of ceremonial and ritual knowledge;
- (iii) Long term residence and historical associate with the area;
- (iv) Seniority in traditional matters concerning the Gulanguru estate;
- (v) Kinship ties;
- (vi) Shared subsection and/or moiety affiliation; and
- (vii) Responsibility for shared Dreaming tracks and/or sacred sites connected with the area.
- 7. The Ilperrelhelam estate group is comprised of those persons:
- (a) Who are patrilineal descendants of any of the following ancestors:
- (i) Pipakarinya (also known as Bandy Charlie), including through his daughter Violet Kngwarrey (also known as Violet Coop);
- (ii) Ngeyntew Kngwarrey and her sister Yapenh;
- (iii) Tommy Turner; or
- (iv) Nugget Smith; or
- (b) Whose mother or father's mother or mother's mother is or was a patrilineal descendant of the

ancestors listed at (a) above; or

- (c) Who have been adopted or incorporated into the descent based relationships referred to in (a) and (b) above in accordance with the traditional laws and customs of the Ilperrelhelam estate group; or
- (d) Who are accepted as members of the Ilperrelhelam estate group by the senior descent based members of the group on the basis of non-descent based connections, including their:
- (i) Birthplace and conception sites;
- (ii) Acquisition of ceremonial and ritual knowledge;
- (iii) Long term residence and historical associate with the area;
- (iv) Seniority in traditional matters concerning the Ilperrelhelam estate;
- (v) Kinship ties;
- (vi) Shared subsection and/or moiety affiliation; and
- (vii) Responsibility for shared Dreaming tracks and/or sacred sites connected with the area.
- 8. The Kuntapulangu estate group is comprised of those persons:
- (a) Who are patrilineal descendants of the ancestor known as Larra Larra Daylight; or
- (b) Whose mother or father's mother or mother's mother is or was a patrilineal descendant of the ancestors listed at (a) above; or
- (c) Who have been adopted or incorporated into the descent based relationships referred to in (a) and (b) above in accordance with the traditional laws and customs of the Kuntapulangu estate group; or
- (d) Who are accepted as members of the Kuntapulangu estate group by the senior descent based members of the group on the basis of non-descent based connections, including their:
- (i) Birthplace and conception sites;
- (ii) Acquisition of ceremonial and ritual knowledge;
- (iii) Long term residence and historical associate with the area;
- (iv) Seniority in traditional matters concerning the Kuntapulangu estate;
- (v) Kinship ties;
- (vi) Shared subsection and/or moiety affiliation; and
- (vii) Responsibility for shared Dreaming tracks and/or sacred sites connected with the area.
- 9. The Other Native Title Holders are other Aboriginal persons who, in accordance with their traditional laws and customs, have rights and interests in respect of the application area, subject to the rights and interests of the Primary Native Title Holders.
- 10. The Other Native Title Holders are:
- (a) Members of neighbouring native title holding groups or estate groups; and
- (b) Spouses of the Primary Native Title Holders.

Native title rights and interests claimed:

- 1. The native title rights and interests of the Primary Native Title Holders are rights in relation to the application area to:
- (a) Access, remain on and use the area;
- (b) Access and take for any purpose the resources of the area; and
- (c) Protect places, areas and things of traditional significance.
- 2. The native title rights and interests of the Other Native Title Holders are rights in relation to the application area to:
- (a) Access, remain on and use the area; and
- (b) Access the resources of the area.
- 3. The native title rights and interests do not confer on the native title holders:
- (a) Possession, occupation, use and enjoyment of the application area to the exclusion of all others;
- (b) Any right to control access to or use of the land and waters of the application area or its resources; or
- (c) Any right to access or take:
- (i) water captured by the holders of Perpetual Pastoral Lease 926; or
- (ii) resources that are the private or personal property of another, including but not limited to:
- A. infrastructure or fixtures;

- B. chattels, equipment, machinery or supplies;
- C. animals that are the private or personal property of another, including stock within the meaning of the *Pastoral Land Act 1992* (NT) and the progeny of any such animal that are the private or personal property of another; and D. plants, crops and grasses that are the private or personal property of another.

b. plants, crops and grasses that are the private of personal property of another.

- 4. The native title rights and interests are subject to and exercisable in accordance with:
- (a) The traditional laws and customs of the native title holders; and
- (b) The laws of the Northern Territory of Australia and the Commonwealth of Australia.
- 5. In the application area, there are no native title rights and interests in:
- (a) Minerals (as defined in s 2 of the Minerals (Acquisition) Act 1953 (NT));
- (b) Petroleum (as defined in s 5 of the Petroleum Act 1984 (NT)); or
- (c) Prescribed substances (as defined in s 3 of the *Atomic Energy (Control of Materials) Act 1946* (Cth) and/or s 5(1) of the *Atomic Energy Act 1953* (Cth)).
