## Additional Information

On 19 December 2022, the Federal Court made a determination that native title exists in part of the determination area - see Widjabul Wia-Bal v Attorney-General of New South Wales (Section 87 Agreement) [2022] FCA 1521. That determination is attached to this Extract. Order 3 of the determination provides that '[t]he determination of native title takes effect upon the date on which the agreement referred to in paragraph 1 of Schedule Four (agreements) is registered on the Register of Indigenous Land Use Agreements, pursuant to section 199B of the Native Title Act 1993 (Cth)'. The agreement referred to in paragraph 1 of Schedule Four (agreements) was registered on the Register of Indigenous Land Use Agreements on 19 April 2023. Therefore the determination has come into effect on 19 April 2023 and has been registered on the National Native Title Register.

### Persons claiming to hold native title:

The Widjabul Wia-bal are the native title claim group on whose behalf the Applicant makes this application. The native title claim group comprises all the descendants of the following apical ancestors:

Bob de Bobbin (also known as Bob Deruhbin), died 1912 at Lismore,

Topsy Brown (also known as Topsy Larken), born 1849, died 1919 at Dunoon,

Johnny Bob (also known as Bob Roberts), born circa 1820,

William 'Billy' King, born 1878 at Lismore,

George Williams, born 1870,

Kitty Barry, born 1841, died 1911 at Blakebrook,

John 'Jack' Kapeen (also known as John 'Jack' Capeen), born circa 1860.
