1. That Lot 7055 DP 1186158 is not subject to any native title rights or interests.
2. The Forster Aboriginal Land Council as holders of freehold title of Lot 7055 DP 1186158 have satisfied the requirements of section 42 of the Aboriginal Land Rights Act 1983 (Cth) and are able to deal with the land as defined by section 40(a) of the Aboriginal Land Rights Act 1983 (Cth).
3. These orders will remain valid even if it is later found that native title exists, or existed, in relation to the area at the time. In such cases, native title holders may be entitled to compensation in accordance with the Native Title Act 1993 (Cth).

The area covered by this application is in the Parish of Forster County of Gloucester within the State of New South Wales that being Lot 7055 in DP 1186158.

The external boundary of the land commences from the intersection of Marina Aenue and Lakeside Crescent. The Boundary then continues along Lakeside Crescent for approximately 200m before turning in a south-east direction along the boundary of DP 45903. The boundary then heads in a north east direction back towards Lakeside Crscent for around 50 meters. The boundary then heads along Lakeside Crescent for around 200m. The boundary then angles in a south-east direction for around 50m. The boundary then runs south for approximately 100m and then continues westerly for 450m until it hits Mariana Avenue.

All of Lot 7055 DP 1186158 is to be covered by this application.
