On behalf of all those Aboriginal People who identify as and are recognised as Kombumerri People, and their descendants.

Native title rights and interests claimed:

The Applicant claims the Native Title rights and interests possessed under the laws of the Kombumerri People which include the right to possession, occupation, use and enjoyment of the land, waters and resources the subject of this application, to the exclusion of all others.

The Kombumerri Peoples have at all times recognised traditional laws and customs relating to the possession, use and enjoyment of the land, waters and resources within their territory, including that water, land and resources which is the subject of this application.

Without limiting the extent of the above claimed rights and interests the applicant further claims Native Title rights in relation to country giving rise to interests and obligations such as spirituality, dreaming and social relationships.

However the applicant and other persons with whom he holds Native Title, claim only those Native Title rights and interests which are consistent with the purpose of valid grants made over the land, waters and resources claimed and the ways in which those lands, waters and resources have been used to the extent

that such grants and usage are consistent with the Native Title Act 1993 (C'th) and the Racial Discrimination Act 1975 (C'th) and reserve their rights and interests which are not consistent
