### **Description of External Boundary of Application**

The external boundary encompasses land within the Local Government areas of Cairns, Johnstone and Eacham and further described as

**Commencing** at a point on the Australian Coastline south of the town of Kurrimine being the mouth of North Maria Creek  
(Approximate Easting 403564 Northing 8031280)

**And bounded thence**

In a westerly direction by the centre of North Maria Creek to its source  
(Approximate Easting 390756 Northing 8032186)

**And bounded thence**

By a line bearing 322° 20' 18" distant 1157 metres to the intersection of South Liverpool Creek with the eastern boundary of State Forest Lot 757 FTY1704  
(Approximate Easting 390049 Northing 8033102)

**And bounded thence**

In a northerly and westerly direction by the eastern boundary of State Forest Lot 757 FTY1704 to the intersection of the boundary of the State Forest with the centre of Liverpool Creek

(Approximate Easting 388374 Northing 8072117)

In an easterly direction by the southern boundary of Eubanagee Swamp National Park Lot 1334 NPW399 to the south east corner of Lot 1334 NPW399  
(Approximate Easting 393019 Northing 8070882)

And bounded thence

By a line approximate bearing 71° 26' 41" distant 4,063 metres to the northeastern corner of Lot 91 Plan NR16 being also a western corner of Lot 1024 NPW151 Ella Bay National Park

**Note regarding geographic coordinates**

Geographic coordinates are in metres and are referenced to Australian Geodetic Datum 1966 (AGD66) Australian Map Grid Zone 55. These coordinates are based on the position of 1:100,000 topographic Maps, BLIN maps sourced from Department of Natural Resources, Qld and the National Native Title Tribunal Original Claims Data.

**Use of Coordinates**

Where coordinates are used within the description to represent cadastral and topographic boundaries or the intersection with such, they are intended as a guide only. As an outcome to the custodians of cadastral and topographic data continuously recalculating the geographic position of their data based on improved survey and data maintenance procedures, it is not possible to accurately define such a position other than by ground survey.
