# QUD6003/01 - Western Yalanji combined #5 and #7 Claim (QC2007/004)

## **Technical Description**

The application area covers:

- 1. all the lands and waters within the external boundary described in Area 1 below, including part of Lot 233 on PH1796 (Mount Mulgrave Holding), that part of Lot 14 on Plan SP250040 (Palmerville Pastoral Holding) which previously formed part of Lot 2 on Plan CP910619 (Palmerville Pastoral Holding) and roads within that external boundary described as Lots 2, 6, 7, 8, 9, and 12 on SP208316 which were formerly part of Lot 2 on CP910619;
- 2. all the lands and waters subject to that part of Lot 14 on Plan SP250040 (Palmerville Pastoral Holding) and part of road described as Lot 9 on SP208316 which previously formed part of Lot 2 on CP910619 (Palmerville Pastoral Holding) and which lie within the external boundary of Area 2 as described below.

# Area 1

Commencing at the intersection of the eastern boundary of Lot 233 on Plan PH1796 and the southern boundary of the Cook Shire Council and extending generally north westerly along that council boundary to its intersection with the southern prolongation of the southernmost south western boundary of Exploration Permit Mineral 11980 (as at Nov 2004); then northerly to the southernmost western corner of that exploration permit; then northerly, westerly and again northerly along western boundaries of that exploration permit and extending north to intersect the southern bank of the Palmer River; then generally south easterly along the southern bank of that river, western and southern boundaries of Lot 7 on Plan CF12 and again southern banks of the Palmer River to the eastern boundary of Lot 1 on Plan CP907719 (Palmer Goldfields Resource Reserve); then generally northerly and generally north easterly along eastern boundaries of that lot and southern boundaries of Lot 1 on Plan CP825797 to the north western corner of Lot 66 on Plan SP161906 (Bonny Glen Holding); then generally southerly along the western boundary of that lot to Latitude 16.189534°

South, being the south west corner of the Parish of Uhrstown and the north western corner of the Parish of Nangee, and also being the point where the boundary leaves the southern bank of Granite Creek; then westerly to the easternmost north east corner of Lot 233 on PH1796 (Mount Mulgrave Holding); then southerly along the eastern boundary of that lot back to the commencement point.

#### Area 2

Commencing at easternmost north east corner of Lot 233 on PH1796 (Mount Mulgrave Holding) and extending easterly to the western boundary of Lot 66 on Plan SP161906 (Bonny Glen Holding) to Latitude 16.189534° South, being the south west corner of the Parish of Uhrstown and the north western corner of the Parish of Nangee, and also being the point where the boundary leaves the southern bank of Granite Creek; then southerly, westerly, again southerly, again westerly and northerly along the boundaries of Lot 14 on SP250040 back to the commencement point.

This application does not include the land and waters within the following:

- o Mining Lease 20239, and
- o Mining Lease 20257.
