

## External boundary description Kaurareg People

### Description

All the sea bounded by a line commencing at a point on the High Water Mark on Cape York Peninsula at Longitude 142.531259° east and extending generally south westerly along that High Water Mark to the right bank of Cowal Creek; then west to the intersection of the High Water Mark and the left bank of Cowal Creek; then generally south westerly again along that High Water Mark to the right bank of the Jardine River; then north westerly to the intersection of the High Water Mark and the left bank of the Jardine River; then generally south westerly again along that High Water Mark to Latitude 10.982123° south; then generally south westerly, generally north westerly, generally north easterly, generally easterly, again generally south easterly, generally easterly, generally south westerly and generally north westerly passing through the following coordinate points back to the commencement point.
