
Barada Kabalbara Yetimarala People





The area subject to the application has been reduced to exclude the area subject to QUD380/2008 Barada Barna People as accepted for registration 13 August 2013. The application area does not include any areas that have not previously been claimed.

External Boundary

Commencing at a point on the centreline of Deep Creek at Latitude 22.653995° South, also being a point on the western boundary of Native Title Determination Application QUD6131/98 Darumbal People (QC2012/008), and extending generally south easterly, generally westerly and again generally south easterly along the western boundary of that application to the intersection of the centrelines of the Melaleuca Creek and the Fitzroy River.

Then south easterly to the centreline of Ten Mile Creek at Longitude 149.862210° East; then generally south westerly, generally westerly and again generally south westerly along the centreline of that creek and an unnamed tributary to its headwaters at Longitude 149.721750° East, Latitude 23.146380° South; then south westerly to the centreline of an unnamed tributary at Longitude 149.719940° East; then generally easterly and generally south easterly along the centrelines of that tributary and Melaleuca Creek to its intersection with the Fitzroy River.

Then generally southerly, generally north westerly and generally south westerly along centrelines of that river and the Mackenzie River to its intersection with the northern boundary of the Lumburra Bimbi Pty Ltd Cultural Heritage Area at Latitude 23.128189° South; then southerly and north westerly along that northern boundary, passing through coordinate point Longitude 148.977458° East, Latitude 23.130563° South, to intersect the eastern boundary of the Nogoa River Drainage Sub-Basin at Latitude 22.957076° South; then generally north westerly along the eastern boundary of that drainage sub-basin to Latitude 22.777622° South; then generally north easterly passing through the following coordinate points:
