1. The Gangalidda People are all of the descendants of the following people:

Greg Thompson, Sophie Thompson, Ernest Thompson, Walter Thompson, Jimmy, Dawudawu Jimmy (King), Grant, George Nark Mirrabaliyajari, Bob Scoles Gunyarbadijarri, Lirrgagujarri, Bob Weber Milgalajarri, Maggie (or Minnie), Kitty, Kitty Wulnanda, Kitty Lirrgagujarri, Dolly, Old Nim, Stumpy Paddy, Mickey Charles, Barny Guldangara, Limilimilda, Johnny Balawayinda, Daisy Lirrgawanjinda, Sandy, Gunalumbu, Ngarilgudu, Malurgudu, Myrna Malalairunanda, Didmanja, Sandy, Garruwala and Charly (Gundirrirri/Ngarrguyumbu/Gulawi) and, who identify and are identified by other Gangalidda People as belonging to the Gangalidda People according to Gangalidda traditional law and custom.

"Descendants" for the purposes of this description includes those individuals who have been adopted by the Gangalidda People.

- 2. The native title claim group are the same people who comprised the Gangalidda People referred to in:
- a) the Orders and approved determination of native title of Justice Cooper in *The Lardil Peoples v State of Queensland* [2004] FCA 298 [QCD2004/001];
- b) the Orders and approved determination of native title of Justice Spender in *Lardil, Yangkaal, Gangalidda & Kaiadilt Peoples v State of Queensland* [2008] FCA 1855 [QCD2008/001];
- c) the Orders and approved determinations of native title of Justice Spender in *Gangalidda and Garawa People v State of Queensland* [2010] FCA 646 [QCD2010/001] and QCD2010/002];
- d) the Orders and approved determination of native title of Justice Dowsett in *Taylor on behalf of the Gangalidda and Garawa Peoples #2 v State of Queensland* [2015] FCA 730 [QCD2015/003]; and e) the Orders and approved determination of native title of Justice Dowsett in *Taylor on behalf of the Gangalidda and Garawa Peoples #1 v State of Queensland* [2015] FCA 731 [QCD2015/002].

The land the subject of this application is adjacent to the land and waters the subject of the approved determinations of native title in those matters.

- 5. The land and waters the subject of the approved determination of native title made in Federal Court proceeding QUD84/2004 on 1 April 2015 [QCD2015/002].
- 6. The land and waters the subject of the approved determination of native title made in Federal Court proceeding QUD66/2005 on 1 April 2015 [QCD2015/003].
- 7. Any land and waters which are the subject of:
- i. A scheduled interest;
- ii. A freehold estate:
- iii. A commercial lease that is neither an agricultural or a pastoral lease;
