Native title rights and interests claimed:

The applicants and other persons with whom the applicants claim to hold native title claim those rights and interests which continue to the extent to which they are consistent with the grants of all those pastoral leases made over the claim area, which include:

- * possession, occupation, use and enjoyment of the land, to the extent consistent with the grants of all those pastoral leases made over the claim area,
- * to collect timber, stones, ochre, resin from the land.
- * to conduct religious activities on and concerning the land.
- * to care for sites.
- * to hold meetings on the land in accordance with Aboriginal tradition.
- * to care for the land in accordance with spiritual obligations
- * to otherwise care for the land in accordance with their tradition and custom.
- * to hunt on the land (fauna).
- * to collect food from the land (flora).
- * to camp on the land (including the erection of shelters).
- * to collect water from the land
- * to practice cultural beliefs concerning births and deaths (including attendance at funerals) on the land.
- * to learn, hold, transmit to younger generations geographical, ritual, spiritual rights and knowledge of sites and country.
- * to regulate others in relation to doing any of these things.
- * to go anywhere on the land, subject to religious avoidance of certain areas.

Area covered by the claim (as detailed in the application):

The area covered by the application is wholly within the State of South Australia and adjacent to the eastern boundary of "the lands" vested in Anangu Pitjantjatjara, pursuant to the Pitjantjatjara Land Rights Act, 1981 (South Australia) and within the Out of Hundreds Alberga and Abminga being the whole of the land and waters within the pastoral leases known as "Agnes Creek (Crown Lease No 2133), Paxton Bluff North (Crown Lease No 2138A) and Paxton Bluff South (Crown Lease No 2190A)" with the exception of the road corridor where the area covered is transversed by the Stuart Highway, the railway corridor where the area covered is transversed by the Central Australian Railway including the Utah Bore Ballast site and the small parcel of freehold land being the whole of the land in Section 1258 Out of Hundreds (Alberga).

The Geographical boundaries of the area covered by the application are clearly delineated and marked on the attached map, being Appendix A to the application.

Some of the indigenous names in this area are; Ipalka, Malu Kapi, Kanja, Yura, Papa Itari and Wipa.
