SAD6011/1998 - Barnjarla Native Title Claim SC1996/004 - Amendment

Port Augusta Township Area

External boundary description

The application area covers all the lands and waters within the external boundary described as:
Commencing at the south westernmost corner of the suburb of Port Augusta West and extending generally northerly and generally south easterly along boundaries of that suburb to the intersection with the centreline of Yorkeys Road (Yorkeys Crossing Road), being a point on the former boundary of the suburb of Port August West; then generally south easterly and generally north easterly along the former boundary of the suburb of Port August West to the western shore line of the Spencer Gulf, being the eastern boundary of the suburb of Port Augusta West.

Further described as generally south easterly along the centreline of the Stuart Highway to the intersection with the prolongation of the centreline of land parcel H540200 S261 (also being the centreline of the Port Augusta Whyalla Railway); then generally north easterly and easterly along the centreline of that land parcel to the eastern boundary of the suburb of Port Augusta West.

Then southerly along boundaries of that suburb to a point at Latitude 32.471072° South; then east to the westernmost northern corner of the northern boundary of the suburb of Port Augusta; then generally easterly and generally south easterly along boundaries of that suburb to the intersection with the western boundary of the suburb of Davenport, being the eastern boundary of Yorkeys Crossing Road; then generally south westerly along the eastern boundary of that road to the south western corner of land parcel F186402 A700; then south westerly to the northernmost corner of land parcel D27656 A2, also being the south western boundary Rogers Street; then generally south easterly along the south western boundary of that street to the south eastern boundary of Flinders Terrace; then generally south westerly along the south eastern boundaries of that terrace to the north eastern boundary of Stuart Terrace; then generally south easterly along the north eastern boundaries of that terrace to the north western boundary of Carlton Parade; then south easterly along the prolongation south easterly of the north eastern boundary of Stuart Terrace to the south eastern boundary of Carlton Parade; then generally north easterly along the south eastern boundaries of that parade to the north eastern corner of land parcel H330600 S1200; then south westerly along the eastern boundary of that

land parcel to the north western corner of land parcel D50346 A3; then generally south easterly along the northern boundaries of that land parcel and generally northerly along eastern boundaries of land parcels H330600 S484, D77019 A12 and D77019 A10 to again the southern boundary of Carlton Parade; then generally north easterly along the southern boundaries of that parade and generally south easterly along the south western boundaries of Racecourse Road to the north eastern corner of land parcel H330600 S430; then south westerly along the eastern boundary of that land parcel and south westerly and south easterly along eastern boundaries of land parcel D50346 A1 to an eastern corner of that land parcel (at approximate Latitude 32.487379°); then south easterly along the prolongation south easterly of the easternmost northern boundary of land parcel D50346 A1 to the western boundary of land parcel H330600 S405; then south westerly along the western boundary of that land parcel, generally south easterly along western and southern boundaries of land parcels H330600 S406 and H330600 S385, and generally south westerly along eastern boundaries of land parcels H330600 S384 to S380 (inclusive) and onwards to the north eastern corner of land parcel H330600 S284; then north easterly to the north western corner of land parcel H330600 S283; then north easterly along the northern boundary of that land parcel, north easterly and south westerly along northern and eastern boundaries of land parcel H330600 S262 and generally south westerly along the eastern boundaries of land parcels H330600 S263 to S268 (inclusive) and onwards to the north eastern corner of land parcel H330600 S269; then generally south westerly along the eastern boundaries of that land parcel, land parcels H330600 S270, H330600 S271 and F10104 A49 to a northern boundary of Augusta Highway; then generally south easterly along the northern boundaries of that highway to the south eastern corner of land parcel D37601 A7; then southerly to the north eastern corner of land parcel F6433 A3; then generally southerly along the eastern boundaries of that land parcel and land parcels H330600 S225 to S220 (inclusive) to the south eastern corner of the last mentioned lot; then southerly to a southern boundary of the suburb of Port Augusta at Longitude 137.797501° East; then generally north westerly along southern and western boundaries of the suburb of Port Augusta to Latitude 32.500000° South; then west across Spencer Gulf to the eastern boundary of the suburb of Port Augusta West; then generally southerly, generally westerly and generally south westerly along boundaries of the suburb of Port Augusta West back to the commencement point.
