Additional Information

On 15 May 2023, the Federal Court made a determination that native title exists in parts of the application area - see Weetra-Height on behalf of the Nauo People v State of South Australia [2023] FCA 454. That determination is attached to this Extract. Order 2 of the determination provides that '[t]he Determination will take effect upon the Nauo Settlement ILUA being registered on the Register of Indigenous Land Use Agreements.' The Agreement referred to in Order 2 was registered on 23 February 2024, and therefore the determination is in effect from 23 February 2024.

Persons claiming to hold native title:

Under the traditional laws and customs of the Nauo People the Native Title Holders are those living Aboriginal people who are the descendants whether by birth or traditional adoption from any of the following Nauo antecedents:

- i. Topsy Ahang;
- ii. Mother of Elizabeth Anderson;
- iii. Mary, mother of Henry Weetra; and
- iv. Frederick Milerah

and who identify as Nauo and are recognised by the other Native Title Holders under those traditional laws and customs as having rights and interests in the Determination Area (together the Native Title Holders).

Native title rights and interests claimed:

The nature and extent of the native title rights and interests of the Native Title Holders in the Native Title Land are the non-exclusive rights to use and enjoy those lands and waters, being:

- (a) the right of access, to be present on, move about on and travel over the Native Title Land;
- (b) the right to take, enjoy, share and exchange the Natural Resources of the Native Title Land for traditional purposes;
- (c) the right to use the natural water resources of the Native Title Land for traditional purposes;
- (d) the right to conduct ceremonies on the Native Title Land;
- (e) the right to maintain and protect sites and places of cultural significance under the traditional laws and customs of the Native Title Holders on the Native Title Land;
- (f) the right to teach on the Native Title Land the physical and spiritual attributes of the Native Title Land;
- (g) the right to hold meetings on the Native Title Land;
- (h) the right to light fires on the Native Title Land for domestic purposes including cooking, but not for the purpose of hunting or clearing vegetation; and
- (i) the right to be accompanied onto the Native Title Land by those people who, although not Native Title Holders, recognise and are bound by the traditional laws and customs of the Native Title Holders and who are:
- i) spouses of Native Title Holders; or
- ii) people required by traditional law and custom for the performance of cultural activities on the Native Title Land.

The application area covers all the land and waters within the external boundary described as:

Commencing at a point on the Lowest Astronomical Tide (LAT) at Longitude 134.891566° East and extending northeasterly to the intersection of the centerlines of the Flinders Highway and Birdseye Highway; then generally north easterly along the centerline of the Birdseye Highway and Kyancutta-Mount Wedge Road to the southern boundary of the Cocata Conservation Reserve; then generally easterly, northerly, easterly, generally northerly and generally north-westerly along boundaries of that reserve to again Mount Wedge Road; then generally north-easterly along the centreline of that road and Elliston Stock Route to the Eyre Highway, also being the western boundary of native title determination SAD6011/1998 Barngarla Native Title Claim (SCD2016/001); then generally southerly along the western boundaries of that native title determination to the south-western boundary of the north-eastern portion of Parcel ID H511200 S39 at approximately Longitude 135.644865° East, Latitude 34.747856° South; then south-westerly to Longitude 135.643266° East, Latitude 34.748119° South; then southerly and south-westerly passing through the following coordinate points:

Then westerly along a line towards Longitude 135.400967° East, Latitude 34.817477° South to its intersection with a 10 metre buffer seaward of the Lowest Astronomical Tide (LAT); then generally north-westerly along a coastal boundary that includes areas:

- Seaward 10 metres from the Lowest Astronomical Tide (LAT);
- All islands and waters of Coffin Bay enclosed by a line that extends from Longitude 135.358070° East. Latitude 34.528230° South to Longitude 135.376706° East, Latitude 34.523967° South; and
- · Seaward 50 metres from the Lowest Astronomical Tide (LAT) of all easily accessible beaches as defined in the table below.

To its intersection with a line extending north easterly from Longitude 134.802539° East, Latitude 33.755822° South and the commencement point; then north easterly back to the commencement point.
