# **Additional Information**

This application comprises Part 1 and Part 2. On 17 March 2021, the Federal Court made a determination in relation to Part 1 - see Stuart v State of South Australia (No 3) [2021] FCA 230. That determination is attached to this Extract. On 9 August 2022, the Federal Court ordered that the Arabana Aboriginal Corporation RNTBC be the prescribed body corporate for this determination and the National Native Title Register (NNTR) has been updated accordingly. Part 2 of this application was dismissed on 21 December 2021 and those orders are attached to this Extract.

## Persons claiming to hold native title:

The Native Title Claim Group comprises those Aboriginal People who both self-identify as Arabana and are recognised as being Arabana by other Arabana people based on:

- 1. Filiation, including by adoption, from an Arabana parent or grandparent; or
- Long term co-residence with Arabana people on Arabana country;

and who satisfy one or more of the following criteria:

- (a) Being raised in Arabana country and being bound by its system of law and custom;
- (b) Living and behaving appropriately with Arabana people in accordance wth Arabana laws and customs;
- (c) Having knowledge of Arabana country and its stories and taking appropriate responsibility, under Arabana custom and law, for that knowledge;
- (d) Having knowledge of Arabana society and the relationships of people within it and seeking to maintain proper relationships amongst Arabana people;
- (e) Having knowedge of Arabana language;
- (f) Displaying an active interest and engagement in Arabana affairs.

## Native title rights and interests claimed:

- 1. The nature and extent of the native title rights claimed and interests in relation to the claim area are non-exclusive rights to use and enjoy in accordance with the native title holders' traditional laws and customs the land and waters of the claim area, being:
- (a) the right to access and move about the claim area;
- (b) the right to live, to camp and, for the purpose of exercising their native title rights and interests, to erect shelters and other structures on the claim area;
- (c) the right to hunt and fish on the land and waters of the claim area;
- (d) the right to gather and use the natural resources of the claim area such as food, medicinal plants, wild tobacco, timber, resin, ochre and feathers, but excluding those resources referred to in Paragraph 12;
- (e) the right to share and exchange the subsistence and other traditional resources of the claim area;
- (f) the right to use the natural water resources of the claim area;
- (g) the right to cook on the claim area and to light fires for domestic purposes but not for the clearance of vegetation;
- (h) the right to engage and participate in cultural activities on the claim area including those relating to births and deaths;
- (i) the right to conduct ceremonies and hold meetings on the claim area;
- (j) the right to teach on the claim area the physical and spiritual attributes of locations and sites within the claim area;
- (k) the right to visit, maintain and protect sites and places of cultural and religious significance to native title holders under their traditional laws and customs on the claim area; and
- (I) the right to be accompanied on to the claim area by those people who, though not native title holders, are:
- (i) spouses of native title holders, or

- (ii) people required by traditional law and custom for the performance of ceremonies or cultural activities on the claim area or;
- (iii) people who have rights in relation to the claim area according to the traditional laws and customs acknowledged by the native title holders.

The native title rights and interest claimed are also subject to the effect of -

- (a) all existing non native title rights and interests;
- (b) all laws of South Australia and the Commonwealth of Australia;
- (c) valid interest conferred under those laws.

# Area covered by the claim (as detailed in the application):

The application area consists of two parts and covers all the lands and waters within the external boundaries described below:

## Part 1 - External Boundary

Commencing at a point of the western boundary of native title determination SAD6017/98 Dieri Native Title Claim (SC1997/004) at Longitude 138.128406 degrees East Latitude 29.693668 degrees South and extending south westerly along that native title determination boundary to the centreline of the Frome River at Latitude 29.712754 degrees South; then generally south easterly along that centreline, also a boundary of that determination to it's intersection with a line joining Longitude 138.442894 degrees East, Latitude 29.777290 degrees South and Longitude 138.250455 degrees East, Latitude 29.844403 degrees South, being a point on the northern boundary of native title determination SAD6001/98 Adnyamathanha No. 1 (SC99/1); then generally south westerly along that native title determination boundary, passing through the following coordinate points.

Longitude (East) Latitude (South) 138.250455 29.844403 138.101751 29.891091 137.932636 29.937779

Then again south westerly along that native title determination boundary to Longitude 137.862798 degrees East, Latitude 29.956059 degrees South, being a point on the southern boundary of native title determination SAD6025/98 Arabana People (SC1998/002); then generally north easterly along that native title determination boundary back to the commencement point passing through the following coordinate points.

Longitude (East) Latitude (South) 138.115372 29.797709 138.143748 29.743720 138.144200 29.734763

# Part 2 - External Boundary

Commencing at the south western corner of S1188 on H831300 and extending northerly and generally easterly along western and northern boundaries of that lot and S1187 on H831300 to the northern corner of S1193 H831300; then south easterly and westerly along boundaries of that lot to an eastern boundary of S1184 on H831300; then westerly, generally south westerly, again westerly, generally northerly and again westerly along the southern boundaries of that land parcel, southern boundaries of A2018 on D34373, S1192 on H831300, eastern, southern and western boundaries of S372 on H8331300, western boundary of S1192 on H831300 and the southern boundary

of S1188 on H831300, back to the commencement point.
