## ATTACHMENT 'A'

- 1. The individuals who comprise the Narungga People's Native title claim group are the biological descendants of the following apical ancestors:
- 2. A 'full-blooded Narungga woman of the Wallaroo area' and Charlie Angie:
- 2.1. The 'full-blooded Narungga woman of the Wallaroo area' married the Chinese man Charlie Angie and gave birth to Sally, Dan, Henry, Jessie, Annie, Chrissie, James, Martin and Elizabeth Angie (Kartinyeri 2002).
- 2.2. Sally Angie married John James and had Oliver James in 1880. Dan Angie married Louisa Edlington of Marion Bay and had three children between 1883 and 1885. Elizabeth Angie married John S(t)ansbury and had Walter and Edward S(t)ansbury in 1876 and 1879. Henry Angie married Maria (Doordy) Adams and had six children 1890 and 1906. Annie Angie married George Reed and had Martha Reed. The records show that almost all of the subsequent descendants lived on the application area.
- 2.3. <u>Family names associated with this ancestor include (but are not limited to): S(t)ansbury, Wilson, Wanganeen, Wilson, Sumner, O'Loughlin and Milera.</u>
- 3. King Tommy and 'a full-blooded woman named Mary':
- 3.1. King Tommy was born in 1826 died in 1886 at Point Pearce. He had two sons and two grandchildren. King Tommy married Queen Mary who was born in about 1830 and died in Point Pearce in 1880. Queen Mary had a son. When King Tommy and Queen Mary passed away, they also left behind the 'children of the old man' (Kartinyeri 2002).
- 3.2. Together, King Tommy and Queen Mary had a daughter called Matilda, who had two children, Louisa and Joe Edwards. Louisa married Alf Spender and Joe married Macey Adams.
- 3.3. It is reported by Kartinyeri (2002) that May Edwards 'could have been the orphan or child of one of King Tommy or Mary's family'. She was adopted by Ted and Lizzie Edwards. May Edwards married Lewis Adams.
- 3.4. The overwhelming majority of subsequent generations lived in the application area.
- 3.5. <u>Family names associated with this ancestor include (but are not limited to): Edwards, Stuart, Graham, Warrior, Williams, Weetra, O'Loughlin, Newchurch, Wanganeen, Wilson</u>
- 4. Ben Simms (of Wallaroo):
- 4.1.1. According to Kartinyeri (2002) Ben Simms was born in Wallaroo around 1848 and lived at Point Pearce. He married Sarah Richardson and together they had a daughter named Ethel Simms. Both Ben's wife and daughter passed away, and Ben went on to marry Clara Wilson.

- 5. An 'Adult Male' Bewes, Ellen Bewes, 'HC' Woman Bewes, Willie Bewes, George Bewes:
- 5.1. The Bewes family were recorded as being Narungga on the Point Pearce records in 1885. While the Bewes family name appears to be non-existent, Kartinyeri (2002) wrote that the Newchurch family are the descendants of Bewes, as Edith Bewes, daughter of Jessie and Eli Bewes, married Richard Newchurch. Records show that subsequent generations mainly lived in the application area.
- 5.2. Records show that subsequent generations mainly lived in the application area.
- 5.3. <u>Family names associated with this ancestor include (but are not limited to): Wilkins, Wilson, Rigney, Milera and Sumner.</u>
- 6. Maria ('Aboriginal Narungga of Walaroo, married to white jailer 'Hughes' at Wallaroo):
- 6.1. According to Kartinyeri (2002) Maria and a male 'Hughes' had Alf Hughes in 1869 at Wallaroo and Susan Hughes in 1871. Graham (1987) corroborates this, writing that Alf Hughes was born in Port Pearce in 1869 and had lived there and at Wallaroo for his whole life. Alf married Lena Goode and had five children, all born at Point Pearce between 1892 and 1903. Susan married Robert Wanganeen and had nine children, all born at Point Pearce between 1888 and 1909.
- 6.2. Records show that an overwhelming majority of the subsequent generations lived in the application area.
- 6.3. <u>Family names associated with this ancestor include (but are not limited to): Graham, Williams, Buckskin, Weetra and Dodd</u>
- 7. S(t)ansbury\* 'Narungga Woman of Moonta'
- 7.1. \*The earlier spelling was 'Stansbury', named after the town on Yorke Peninsula. The spelling was later changed to 'Sansbury'
- 7.2. S(t)ansbury 'Narungga woman of Moonta' and Captain Walter Hughes of Moonta Mines had John S(t)ansbury in about 1854. John had a relationship with Elizabeth Angie of Narridy, and together they had Walter S(t)ansbury in 1876 at Point Pearce and Edward S(t)ansbury in 1879 (Kartinyeri 2002). Walter married Ethela Adams and together they had nine children at Point Pearce between 1897 and 1910 and Edward married Jessie Camilla Johnson and had seven children at Point Pearce between 1901 and 1915. Edward later married Jessie Maude Wilson and they had six children at Point Pearce between 1925 and an undisclosed year, probably between 1935 and 1940 (Kartinyeri 2002).
- 7.3. The records show that subsequent generations lived in the application area, with a few families moving to Adelaide.
- 7.4. <u>Family names associated with this ancestor include (but are not limited to): Kropinyeri, Turner, Wanganeed, Milera, Newchurch, Smith, Harris and O'Brien</u>

## 8. Annie Radford

- 8.1. Annie Radford was born in Balaklava in 1886 and died in Wallaroo in 1940. She married Jack Abdulla Senior (Afghan) and together they had seven children. It is unclear whether these children lived their lives in Narungga country. It is likely that the children spent some time there, as that is where Annie died and was buried.
- 8.2. One of Annie and Jack's children, William Abdulla, married Florence Bertha Warrior who was from Point Pearce. Together they had three children, all born on Narungga country between 1936 and 1947.
- 8.3. Annie's second marriage was to Walter Richards Senior of Beltana, to whom she had five children. It is also unclear whether these children lived in Narungga country, although her son, Benjamin Richards, died there in 1949.
- 8.4. <u>Family names associated with this ancestor include (but are not limited to): Abdulla, Richards, Kite and Hunter</u>
- 9. In the Narungga Family History project (Hemming: 1992), the families with at least one original Narungga ancestor are listed as: Abdulla, Angie, Edwards, Hughes, Sansbury, Bewes (surname has 'died out'), Goode (surname has 'died out'), James (no living descendants), Simms (surname has 'died out'), Penton (surname has 'died out').
