Dieri #3 Native Title Claim

External boundary description

The amended application area covers all the land and waters within the external boundary described as:

Commencing at the intersection the centreline of Warburton River with Longitude 137.266565° East and extending south, generally south easterly and generally southerly passing through the following coordinate points:

Then again southerly along a line towards a point at Longitude 137.918433° East, Latitude 29.038588° South to its intersection with the southern boundary of Section S1468 on Plan H833000, then generally westerly and generally north westerly along western boundaries of that section and western and southern boundaries of Allotment A2036 on Plan D38061 (Kalamurina Pastoral Lease) and Allotment B425 on Plan H831400 (Kallakoopah West Pastoral Lease), also being eastern boundaries of Section 1466 on Plan H832200 (Lake Eyre National Park) to the centreline of Warburton River; then generally northerly and generally easterly along the centreline of that river and the centreline of Macumba River to the centreline of an unnamed creek at Longitude 137.243349° East, Latitude 27.849146° South, also being a point on the southern boundary of Native Title Determination Application

SAD6016/1998 The Wangkangurru / Yarluyandi Native Title Claim (SC1997/003); then generally south easterly along the centreline of that unnamed creek and then Warburton River, also being that Native Title Determination Application SAD6016/1998 The Wangkangurru / Yarluyandi Native Title Claim (SC1997/003) back to the commencement point.
