SAD84/2021 – Wirangu Sea Claim #2 – (SC2021/003) – Part A

Boundary description

Commencing at a point on the Lowest Astronomical Tide (LAT) at the westernmost point of Cape Bauer, at approximately Longitude 134.060159° East, Latitude 32.723396° South; then extending generally south easterly along that Lowest Astronomical Tide (LAT) to the intersection with a line extending north-easterly from Longitude 134.391364° East, Latitude 33.333146° South to the northernmost corner of Parcel ID D26699 A3 (being approximately 6 km north of the locality of Witera); then south westerly along that line to its intersection with a 10 metre buffer seaward of the Lowest Astronomical Tide (LAT); then generally north-westerly along a coastal boundary that includes areas:

- Seaward 10 metres from the Lowest Astronomical Tide (LAT);
- All internal islands and waters of Baird Bay seaward of the Lowest Astronomical Tide (LAT), and enclosed by a line that extends from Longitude 134.358389° East, Latitude 33.187207° South to Longitude 134.352691° East, Latitude 33.188359° South;
- All of Jones Island at the entrance of Baird Bay and surrounding waters extending seaward 10 metres from the Lowest Astronomical Tide (LAT); and
- Seaward 50 metres from the Lowest Astronomical Tide (LAT) of all easily accessible beaches as defined in the table below.

To the intersection with a line extending north easterly from a point on a 300m buffer seaward of the Low Water Mark at Latitude 32.724291° South (south west of Cape Bauer) and the commencement point, then north easterly back to the commencement point.

Boundary description

Commencing at a point on the Lowest Astronomical Tide (LAT) at Longitude 134.891566° East and extending south-westerly along a line to Longitude 134.802539° East Latitude 33.755822° South to its intersection with a 10 metre buffer seaward of the Lowest Astronomical Tide (LAT); then generally north-westerly along a coastal boundary that includes areas:

- Seaward 10 metres from the Lowest Astronomical Tide (LAT);
- All internal islands and waters of Horne Bay (Waterloo) (enclosed by a line that extends from Longitude 134.874215° East, Latitude 33.652026° South to Longitude 134.862809° East, Latitude 33.644993° South);
- All internal islands and waters of Venus Bay (enclosed by a line that extends from Longitude 134.660613° East, Latitude 33.230053° South to Longitude 134.660091° East, Latitude 33.227137° South); and
- Seaward 50 metres from the Lowest Astronomical Tide (LAT) of all easily accessible beaches as defined in the table below.

To the intersection with a line extending north-easterly from Longitude 134.391364° East, Latitude 33.333146° South to the northernmost corner of Parcel ID D26699 A3, (being approximately 6 km north of the locality of Witera); then north-easterly along that line to a point on the Lowest Astronomical Tide (LAT) of the coastline; then generally south-easterly along the Lowest Astronomical Tide (LAT) of the coastline back to the commencement point.
