### WAD6236/1998 The Malgana Shark Bay People's Application (WC1998/017)

#### External boundary description

The application area covers all the land and waters within the external boundary described as:

Commencing at the intersection of the twelve (12) nautical mile territorial sea limit and Latitude 24.563549° South, and extending easterly and south easterly through the following coordinate point to a point at Longitude 114.052259° East, 25.859000° South:

then south easterly to the high water mark at Latitude 25.907540° South, also being the western edge of the strip of 40 metre-wide Unallocated Crown Land between that high water mark and Pastoral Lease N050177 (Wooramel); then generally northerly along that high water mark to the right bank of the Wooramel River; then generally northerly and generally easterly along the right bank of the Wooramel River, passing through Pastoral Leases N050177 (Wooramel), N050646 (Meedo), following the northern boundary of Lot 254 on P238582 (UCL); then passing through N049969 (Towrana) and N049939 (Carey Downs) to a point at Longitude 115.362930° East; then generally southerly passing through the following coordinate points:

then south westerly to an eastern corner of Pastoral Lease N049949 (Talisker) at Latitude 26.277172° South; then southerly along an eastern boundary of that pastoral lease to Latitude 26.598612° South, then generally westerly through the following coordinate points to a point on the twelve (12) nautical mile territorial sea limit at Latitude 26.649343° South:

then generally north westerly and generally north easterly along the twelve (12) nautical mile territorial sea limit back to the commencement point.

For the avoidance of any doubt, the application excludes any area subject to:

- WAD6161/1998 Gnulli (WC1997/028) as accepted for registration 13 May 2014;
- WAD6136/1998 Nanda People (WC2000/013) as accepted for registration 10 December 2001;
- WAD6033/1998, WAD382/2017 Wajarri Yamatji Part B (WCD2018/002) as determined by the federal court on 23 April 2018.

- Application boundary compiled by National Native Title Tribunal based on information or instructions provided by the applicants.
- Cadastre and tenure data sourced from Landgate, WA (January 2018).
- Rivers / Creeks based on Topographic data sourced from Landgate, WA (8 October 2015).
- High Water Mark based on data sourced from Landgate, WA (January 2018).
- Twelve (12) nautical mile territorial sea limit based on Australian Maritime Boundaries sourced from Geoscience Australia (6th Edition released February 2006).

##### Reference datum

Geographical coordinates have been provided by the NNTT Geospatial Services and are referenced to the Geocentric Datum of Australia 1994 (GDA94), in decimal degrees and are based on the spatial reference data acquired from the various custodians at the time
