

WAD6064/1998 WUTHA (WC1999/010)

This Description is an interpretation of the areas that remain part of the application following the orders of Justice Lindgren made on 5 February 2007 (*Harrington Smith & Ors v State of Western Australia & Ors*).

The Remaining part of the application consists of five (5) separate areas.

Area 1

Commencing at the north western corner of Yarrabubba Pastoral Lease (N049683) and extending easterly, generally southerly and westerly along boundaries of that pastoral lease to Longitude 118.973728° East, then south easterly to intersect an eastern boundary of Road No. 4274 at Latitude 27.563078° South, then generally south westerly along boundaries of that road to a northern boundary of Native Title Determination WAD6123/1998 Badimia People (WCD2015/001) at Latitude 28.007165° South, then westerly, generally north easterly and again westerly along boundaries of that determination passing through the following coordinate points.

Then northerly to the southernmost corner of Cue Townsite, then north easterly and north westerly along boundaries of that townsite to an eastern boundary of the Unallocated

Crown Land (UCL) passing through a central severance of Reserve 7273, then north easterly along the boundary of that UCL to a southern boundary of Austin Downs Pastoral Lease (N050063), then north easterly back to the commencement point.

Area 2

Commencing at a point on an eastern boundary of Reserve 10513 at Latitude 27.998687° South and extending generally southerly along boundaries of that reserve to a northern boundary of Pinnacles Pastoral Lease (N049812), then easterly along the boundary of that pastoral lease to Longitude 120.584277° East, then generally south westerly and generally southerly passing through the following coordinate points.

Then southerly to a northern boundary of Bulga Downs Pastoral Lease (N050442) at Longitude 119.891380° East, then easterly and southerly along the boundaries of that pastoral lease to a corner at Latitude 26.635686° South, again southerly to the northernmost north western corner of Perrinvale Pastoral Lease (N050261), again southerly and westerly along boundaries of that pastoral lease to Longitude 119.975288° East, then generally south easterly and generally southerly passing through the following coordinate points.

Then north westerly to an eastern boundary of Native Title Determination WAD6123/1998 Badimia People (WCD2015/001) at Latitude 28.527256° South, then generally north easterly along boundaries of that determination passing through the following coordinate points.

Then north easterly to the northern boundary of Road No. 4333 (Mount Magnet – Sandstone Road), then generally easterly along the boundary of that road and the northern boundary of Road No. 9473 (Agnew-Sandstone Road) to a western boundary of Booylgoo Spring Pastoral Lease (N050557) (formerly part of Kaluwiri Pastoral Lease 3114/1232), then southerly,

easterly and northerly along boundaries of that pastoral lease, southern and eastern boundaries of Depot Springs Pastoral Lease (N049967) to Latitude 27.998691° South, then easterly back to the commencement point.

Area 3

Commencing at the northernmost north eastern corner of Perrinvale Pastoral Lease (N050261) and extending southerly and easterly along boundaries of that pastoral lease to Longitude 120.465726° East, then south westerly and northerly passing through the following coordinate points.

Then northerly to a northern boundary of again Perrinvale Pastoral Lease (N050261) at Longitude 120.213843° East, then easterly along the boundary of that pastoral lease back to the commencement point.

Area 4

Commencing at a point on a western boundary of Weebo Pastoral Lease (N049440) at Latitude 28.079028° South and extending northerly, easterly and again northerly along boundaries of that pastoral lease to Latitude 27.998685° South, then easterly and generally south westerly passing through the following coordinate points.

Again south westerly back to the commencement point.

Area 5

Commencing at the westernmost south western corner of Windidda Pastoral Lease (N049460) being a point on the southern boundary of Native Title Determination WAD6164/1998, WAD248/2007, WAD181/2012 Wiluna (WCD2013/004) and extending generally easterly along boundaries of that determination and pastoral lease to Longitude

122.339980° East, then generally southerly and generally southwesterly passing through the following coordinate points.

Then westerly to a western boundary of Banjawarn Pastoral Lease (N050400) at Latitude 27.761740° South, then generally northerly and easterly along boundaries of that pastoral lease to the southernmost south western corner of Wonganoo Pastoral Lease (N050007), then northerly along the western boundary of that pastoral lease to the northernmost north eastern corner of Melrose Pastoral Lease (N049788), then easterly to again a corner of Wonganoo Pastoral Lease (N050007), then generally northerly along the eastern boundaries of that pastoral lease to the southernmost south eastern corner of Yelma Pastoral Lease (N049504), being a point on the southern boundary of Native Title Determination WAD6164/1998, WAD248/2007, WAD181/2012 Wiluna (WCD2013/004) then generally northerly and generally easterly along boundaries of that determination and pastoral lease back to the commencement point.
