

**WAD6090/1998 Kuruma Marthudunera (Combined) WC1999/012**

*Area remaining on the Register of Native Title Claims (RNTC) following the determination of WAD6090/1998 Kuruma Marthudunera (Part A) (WCD2016/006) by the Federal Court of Australia on 1 November 2016.*

**External Boundary Description**

The application area covers all the land and waters within the external boundary described as:

All those lands and waters commencing at the intersection of a western boundary of Native Title Determination Application WAD127/1997 Yaburara and Mardudhunera People (WC1996/089) with Latitude 21.195307 South and extending generally southeasterly then northeasterly along the boundary of that native title application to Longitude 116.741674° East; then generally southeasterly through the following coordinate points:

Then southeasterly to the intersection of a western boundary of Native Title Determination WAD6017/1996 Ngarluma/Yindjibarndi (WCD2005/001) with Latitude 21.446870° South; then generally southwesterly, generally easterly, generally southeasterly; westerly and southerly along the boundaries of that native title determination to Latitude 21.667808° South; then southwesterly to Longitude 116.526127° East, Latitude 21.925662° South; then southeasterly to the northwestern corner of the northernmost northwestern severance of Mt Stuart Pastoral Lease (N050169); then southerly along the western boundary of that severance to the intersection with a northern boundary of Native Title Determination WAD6007/2001, WAD126/2005 Puutu Kunti Kurrama and Pinikura People #1 and #2 (WCD2015/003); then generally westerly and generally northwesterly along boundaries of that native title determination to Longitude 115.912264° East, Latitude 22.179325° South; then generally

- Native Title Determination Application WAD 127/1997 Yaburara & Mardudhunera people (WC1996/089), as accepted for registration on 17 April 2014.
- Native Title Determination WAD6090/1998 Kuruma Marthudunera (Part A) (WCD2016/006) as determined in the Federal Court on the 1 November 2016.
