## WAD6164/1998 Wiluna (WC1999/024)

This description is an interpretation of the area that remains as a result of the following Native Title Determinations and Federal Court Orders for:

- WAD6164/1998 Wiluna (WC1999/024) dated 29 July 2013 which discontinues those parts of the Wiluna application subject to native title determination applications WAD50/2010 Birriliburu #3 (WC2010/002) and WAD181/2012 Wiluna #3 (WC2012/007); and
- WAD241/2004 Wiluna #2 (WC2013/007) dated 3 September 2013 which dismisses those parts of WAD6164/1998 Wiluna (WC1999/024) subject to the Wiluna #2 application.

# External boundary description of remaining area.

The remaining application area covers all land and waters within the external boundary described as:

### Portion 1:

Commencing at the northern-most northwestern corner of Pastoral Lease 3114/1070 (Carnegie) and extending generally easterly and generally southerly along boundaries of that pastoral lease to the northeastern corner of Pastoral Lease 3114/1066 (Prenti Downs); Then generally southerly along boundaries of that pastoral lease to Latitude 26.527203° South; Then southwesterly to Latitude 26.654609° South, Longitude 122.927246° East; Then westerly to the southeastern corner of Pastoral Lease PL K601976 (Windidda); Then northerly, generally westerly and generally southerly along the boundaries of that pastoral lease to the eastern-most southeastern corner of Pastoral Lease 3114/1067 (Yelma); Then generally westerly along the southern boundaries of that pastoral lease to intersect the eastern boundary of Pastoral Lease 3114/472 (Lake Violet); Then southerly and westerly along the boundaries of that pastoral lease to Longitude 121.017081° East; Then generally northwesterly through the following coordinate points;

Then northwesterly to intersect a western boundary of Pastoral Lease 3114/472 (Lake Violet) at Latitude 26.798382 South; Then northerly and generally westerly along boundaries of that pastoral lease to the southern-most southeastern corner of Pastoral Lease 3114/1260 (Millbillillie); Then westerly along the southern boundary of that pastoral lease to an eastern

boundary of Reserve 9699; Then southeasterly along that boundary of that reserve to Latitude 26.758218° South; Then west to the eastern boundary of Reserve 19456; Then generally southerly, westerly, northerly and easterly along boundaries of that reserve to Longitude 120.193480 East; Then generally northerly and generally westerly passing through the following coordinate points;

Then westerly to the easternmost corner of the westernmost severance of Pastoral Lease 3114/1260 (Millbillillie); Then westerly and northerly along boundaries of that pastoral lease to a southern boundary of Pastoral Lease 3114/1131 (Paroo); Then generally westerly, generally northeasterly and again generally westerly along the boundaries of that pastoral lease to Road No. 4274; Then generally northeasterly and northerly along the eastern boundaries of that road to the western-most northwestern corner of Pastoral Lease 3114/1049 (Cunyu); Then generally easterly along the northern boundaries of that pastoral lease to a western boundary of Pastoral Lease 3114/654 (Granite Peak); Then northerly and generally easterly, southerly and easterly along the northern boundaries of that pastoral lease to the northern-most northwestern corner of Unallocated Crown Land being Lot 4 as shown on Deposited Plan 220354; Then southerly, westerly, again southerly, easterly, again southerly and again easterly along the boundaries of that lot to the southwestern corner of Unallocated Crown Land being Lot 3 as shown on Deposited Plan 220354; then easterly, northerly, again easterly and again northerly along the boundaries of that lot to the western boundary of Pastoral Lease 3114/1070 (Carnegie); Then northerly and westerly along the boundaries of that pastoral lease to the easternmost corner of a parcel of Unallocated Crown Land (UCL) being a Stock Route; Then westerly along the southern boundary of that parcel to the easternmost corner of the western severance of Pastoral Lease 3114/1070 (Carnegie); Then westerly and northerly along the boundaries of that severance to its northernmost corner; Then northwesterly along the southwestern boundary of again a parcel of UCL (Stock Route) to the southern boundary of Pastoral Lease 3114/1062 (Glenayle); Then easterly to Latitude 25.445169° South, Longitude 122.197951° East; then northerly to the southernmost corner of the eastern severance of Pastoral Lease 3114/1062 (Glenayle), also being a point on

the boundary of Pastoral Lease 3114/1070 (Carnegie); Then northerly along the boundary of that pastoral lease back to the commencement point.

## Portion 2:

Application area also covers all land within an external boundary commencing at a point on the northern boundary of Unallocated Crown Land being Lot 3 as shown on Deposited Plan 220354 at Longitude 122.000000° East; Then extending due south to Latitude 25.600000° South; Then due east to Longitude 122.100000° East; Then due north to the northern boundary of Unallocated Crown Land being Lot 3 as shown on Deposited Plan 220354; then westerly along the boundary of that lot back to the commencement point.

## Excluded Area:

Application area excludes all land and waters within the external boundary described as:

Commencing at the westernmost northwestern corner of Unallocated Crown Land being Lot 27 as shown on Deposited Plan 220011 and extending easterly, northerly and generally easterly along boundaries of that lot to the westernmost corner of Unallocated Crown Land being Lot 8 as shown on Deposited Plan 220011; Then easterly and southerly along boundaries of that lot to a northeastern corner of Unallocated Crown Land being Lot 27 as shown on Deposited Plan 220011; then southerly, easterly and again southerly along boundaries of that lot to Latitude 26.198661° South; Then westerly to Longitude 121.584723° East, Latitude 26.198662° South; Then due south to Latitude 26.248662° South; Then due east to an eastern boundary of Unallocated Crown Land being Lot 27 as shown on Deposited Plan 220011; Then southerly, generally westerly, northerly, westerly, northwesterly and northerly along boundaries of that lot back to the commencement point.

For the avoidance of doubt, the application area also excludes all land and waters subject to:

- Native title determination WAD6284/1998 Birriliburu People Part A (WCD2008/002) as determined in the Federal Court on 20 June 2008.
- Native title determination application WAD50/2010 Birriliburu #3 (WC2010/002) as filed in the Federal Court on 15 March 2010.
- Native title determination application WAD181/2012 Wiluna #3 (WC2012/007) as filed in the Federal Court on 3 August 2012.
- Native title determination application WAD248/2007 Tarlpa (WC2007/003) as accepted for registration on 3000 April 2008.
