

PROPOSED WILUNA NATIVE TITLE CLAIM

Boundary Description

Starting at the northern most north western corner of Pastoral Lease 3114/1062 (Glenayle) and extending easterly and generally southerly along boundaries of that pastoral lease to Latitude 24.991542 south; Thence south to the northern boundary of Reserve 36469; Thence westerly and southerly along boundaries of that reserve to a northern boundary of the aforesaid pastoral lease; Thence generally easterly and southerly along boundaries of that pastoral lease to a northern boundary of Pastoral Lease 3114/1070 (Carnegie); Thence generally easterly and southerly along boundaries of that pastoral lease to the north eastern corner of Pastoral Lease 3114/1066 (Prenti Downs); Thence generally southerly along boundaries of that pastoral lease to Latitude 26.528557 south; Thence south westerly to Latitude 26.655959 South, Longitude 122.925864 East; Thence westerly to the south eastern corner of Pastoral Lease 3114/1065 (Windidda); Thence generally westerly along the southern boundaries of that pastoral lease and Pastoral Lease 3114/1067 (Yelma) to intersect the eastern boundary of Pastoral Lease 3114/960 (Lake Violet); Thence southerly and westerly along the boundaries of that pastoral lease to Longitude 121.015680 East; Thence generally northwesterly through the following co-ordinate positions;

Thence north westerly to again intersect a western boundary of the last mentioned pastoral lease at Latitude 26.79971 South; Thence northerly and generally westerly along boundaries of that pastoral lease to the southern most south eastern corner of Pastoral Lease 3114/1253 (Millbillillie); Thence westerly along the southern boundary of that

pastoral lease to a eastern boundary of Reserve 9669 (Peak Hill Stock Route); Thence south easterly along that boundary Latitude 26.759540 South; Thence west to the eastern boundary of Reserve 19456; Thence south, west, north and east along boundaries of that reserve to Longitude 120.192079 East; Thence generally northerly and generally westerly passing through the following co-ordinate positions;

Thence westerly to a southern boundary again on Pastoral Lease 3114/1253 (Millbillillie); Thence westerly and northerly along boundaries of that pastoral lease to a southern boundary of Pastoral Lease 3114/1131 (Paroo); Thence generally westerly, north easterly and westerly along the boundaries of that pastoral lease to Road No. 4274. Then generally north easterly and northerly along the eastern boundaries of that road to the westernmost northwestern corner of Pastoral Lease 3114/1049 (Cunyu); Thence generally easterly along the northern boundaries of that pastoral lease to a western boundary of Pastoral Lease 3114/654 (Granite Peak); Thence northerly and generally easterly along the northern boundaries of that pastoral lease to the north eastern corner of Pastoral Lease 3114/445 (EURAHEEDY); Thence generally easterly along the northern boundaries of that pastoral lease to a western boundary of Pastoral Lease 3114/1070 (Carnegie); Thence generally northerly along the western boundaries of that pastoral lease to Latitude 25.457401 South; Thence north westerly to a southern boundary of Pastoral Lease 3114/1062 (Glenayle) Longitude 122.185549; Thence generally westerly and northerly along the boundaries of that pastoral lease back to the stating point.
