**PROPOSED SINGLE NOONGAR #1 NATIVE TITLE DETERMINATION
APPLICATION**

Area of Application (geographic extent) – 194,000 sq km

All the land, waters and seas above the Low Water Mark commencing at the north western corner of the Shire of Coorow being a point on the northern boundary of the South West Land and Sea Aboriginal Corporation RATSI Boundary and extending generally easterly along that Shire boundary and the northern boundary of the Shire of Dalwallinu to Longitude 116.558401 East, then generally south easterly through the following coordinates;

Then south easterly to the eastern boundary of the Shire of Kondinin at Latitude 32.602447° South, again being a point on the South West Land and Sea Aboriginal Corporation RATSI Boundary, then southerly and easterly along that shire boundary and the northern boundary of the Shire of Ravensthorpe to intersect Native Title Determination Application WG6020/98 Ngadju (WC99/2), then generally south along the

boundaries of that application to the northern boundary Native Title Determination Application WAG6097/98 The Esperance Nyungars (WC96/64), then westerly and generally southerly along boundaries of that application to the Low Water Mark of the Southern Ocean at Mason Bay, then southerly to intersect the three (3) nautical mile coastal waters boundary at Longitude 120.430008° East, then generally westerly and generally northerly along that boundary to the south west corner of Native Title Determination Application WG6085/98 Harris Family (WC96/41) at Latitude 34.221295° South; then generally easterly, generally northerly, generally north easterly and generally westerly along the southern, eastern and northern boundaries of that application by continuing easterly to a point on the coast at Latitude 34.222883° South, then north easterly to a north west corner of the Chapman Road road reserve at Longitude 115.028597° East, then generally easterly along the northern boundaries of that road reserve to the western boundary of the Bussell Highway road reserve at Latitude 34.216081° South, then generally northerly along the western boundaries of that road reserve to the intersection with the Carburnup River at Latitude 33.698833 ° South, then north easterly to a point on the northern boundary of the Bussell Highway road reserve at Longitude 115.418556° East, then generally north easterly along the northern boundaries of that road reserve to the northern bank of the Capel River, then generally north westerly along the northern banks of that river to where the mouth of that river meets the coast, then westerly to intersect the three (3) nautical mile coastal waters boundary again at Latitude 33.510419 ° South; then generally northerly along that boundary to Latitude 29.937324° South and then easterly back to the commencement point.

This application specifically excludes the land and waters within Native Title Determination Application WG6085/98 Harris Family (WC96/41) as registered 15th September 1999.

This application specifically excludes the land and waters within Native Title Determination Application WAG0065/98 Central West Goldfields (WC99/29) as registered 4th October 1999.

This application specifically excludes the land and waters within Native Title Determination Application WAG6020/98 Ngadju (WC99/2) as registered 28th August 2000.

This application specifically excludes the land and waters within Native Title Determination Application WAG6097/98 Esperance Nyungars (WC96/64) as registered 16th July 1999.

Reference Datum
