WAD28/2019 Wajarri Yamatji #1 (WC2004/010) - Remaining application area

This description is an interpretation of the application area that remains undetermined following the Orders made within the determinations of native title by the Federal Court of Australia on 29 July 2021 for WAD278/2018, WAD373/2018 Wajarri Yamatji Part D (WCD2021/004) and WAD382/2017 Wajarri Yamatji Part E (WCD2021/005).

External boundary description

The remaining application area covers all the land and waters within the external boundary described as:

Commencing at the westernmost point of the southern severance of Portion 2 of Native Title Determination WAD6033/1998 Wajarri Yamatji Part A (WCD2017/007) and extending generally north easterly along the southern boundaries of that severance to its easternmost point; then north easterly to the westernmost point of the northern severance of Portion 2 of again Native Title Determination WAD6033/1998 Wajarri Yamatji Part A (WCD2017/007); then generally easterly, generally north easterly and generally north westerly along the southern boundaries of that severance to its northernmost point; then north easterly to intersect a western boundary of Yallalong Pastoral Lease (N049486) at Latitude 27.520517° South; then northerly along the western boundary of that pastoral lease to its intersect with the southern boundary of Portion 1 of Native Title Determination WAD6033/1998 Wajarri Yamatji Part A (WCD2017/007); then generally north easterly and generally south easterly along the southern boundaries of that native title determination to intersect with the westernmost corner of the southernmost portion of Native Title Determination WAD382/2017 Wajarri Yamatji Part E (WCD2021/005); then south easterly along the southern boundary of that native title determination to intersect with again a southern boundary of Portion 1 of Native Title Determination WAD6033/1998 Wajarri Yamatji Part A (WCD2017/007); then generally south easterly along the southern boundaries of that native title determination to its southernmost corner, being also a point on the northern boundary of Native Title Determination WAD21/2019, WAD31/2019, WAD27/2019, WAD19/2019, WAD345/2019 Yamatji Nation (WCD2020/001); then generally south westerly and generally north westerly along the northern boundaries of that native title determination to Longitude 115.119027° East, Latitude 28.056299° South, being a south eastern corner on the eastern boundary of Native Title Determination Application WAD30/2019 Nanda People (WC2000/013); then generally northerly along the eastern boundary of that native title determination application passing through the following coordinate points:
