

WAD25/2012 Yi-Martuwarra Nurrara (WC2012/002) – Remaining Area

This description is an interpretation of the area of the that remains as a result of the Part A Determination of WAD25/2012 Yi-Martuwarra Nurrara (WCD2018/001) by the Federal Court of Australia on 12 March 2018.

External boundary description

The application area covers all the land and waters within the areas identified below:

Area A

That part of Petroleum Exploration Permit EP417 R1 (as at 1 February 2012) excluding any area subject to Reserve 5280, Yougawalla Pastoral Lease (PL N050502), Lot 331 on P055300 (Unallocated Crown Land) and native title determinations WAD6077/1998 Nurrara Part A and Part B (WCD2007/005 and WCD2012/005).

Area B

That part of Petroleum Exploration Permit EP456 (as at 1 February 2012) that falls within the area defined as:

Commencing at Longitude 123.501304° East, Latitude 19.044946° South, being a point on the western boundary of Native Title Determination WAD6077/1998 Nurrara Part A (WCD2007/005) and extending southerly along that boundary to Longitude 123.501315° East, Latitude 20.998619° South; then extending northerly to Longitude 123.481307° East, Latitude 20.090213° South, being the south eastern most corner of Native Title Determination WAD6100/1998 Karajarri People (Area A) (WCD2002/001); then northerly along the eastern boundary of that native title determination to the intersection with a southern boundary of Native Title Determination WAD6099/1998 Nyikina Mangala (WCD2014/003) at Longitude 123.421026° East, Latitude 19.044947° South; then easterly along a southern boundary of that native title determination back to the commencement point.

For the avoidance of doubt the application area does not include any area subject to:

- Native Title Determination WAD6077/1998 Nurrara Part A (WCD2007/005) as determined in the Federal Court on 09/11/2007.
- Native Title Determination WAD281/2008 Nurrara 2 – Area C (WCD2012/004) as determined in the Federal Court on 27/11/2012.
- Native Title Determination WAD6077/1998 Nurrara - Area B (WCD2012/005) as determined in the Federal Court on 27/11/2012.
- Native Title Determination WAD25/2012 Yi-Martuwarra Nurrara Part A (WCD2018/001) as determined in the Federal Court on 12/03/2018.
