### External boundary description

The application area covers all the land and waters within the external boundary described as:

Commencing at a point on the southern boundary of Native Title Determination WAD49/98 Bardi Jawi at Latitude 16.794801° South, Longitude 123.417959° East; also being a point on the southern boundary of Native Title Determination Application WAD6255/98 Mayala (WC1998/039) and extending easterly along the southern boundary of that native title determination application to the intersection with Native Title Determination WAD6061/98 Dambimangari at Latitude 16.794801° South, Longitude 123.501280° East; then southerly along the western boundary of that native title determination to the Intersection with Native Title Determination Application WAD104/11 Mawadjala Gadjidgar (WC2011/003) at Latitude 16.917519° South; then westerly, south westerly and south easterly along western boundaries of that native title determination application passing through the following coordinate points.

Then south easterly again along the boundary of that native title determination application to the Intersection with the westernmost north western corner of Native Title Determination Application WAD258/12 Warrwa #2 (WC2012/009); then southerly along the western boundary of that native title determination application to Latitude 17.234082° South, Longitude 123.584619° East; then westerly to the south easternmost corner of Reserve 1834; then westerly along the southern boundary of that reserve and to the north easternmost corner of Pastoral Lease PL H649773 (Yeeda), also being a point on the northern boundary of Native Title Determination Application WAD6099/1998 Nyikina Mangala (WC1999/025); then generally westerly and southerly along the northern and western boundaries of that pastoral lease (and that native title determination application) to its intersection with the centreline of the Fraser River; then generally westerly along the centreline of that river to its intersection with the western boundary of Pastoral Lease PL H910623 (Mt Jowlaenga); then southerly along the western boundary of that pastoral lease to its south western corner; then southerly to the northern boundary of Native Title Determination WAD6006/98 Rubibi Community at Longitude 122.853944° East; then generally westerly along the northern boundaries of that native title determination, also being the northern boundaries of Pastoral Lease 3114/499 (Roebuck Plains), to its intersection with Native Title Determination Application WAD124/10 Jabbir Jabbir People (WC2010/005) at Longitude 122.510750° East; then northerly along the eastern boundary of that native title determination application to the south western corner of Pastoral Lease 398/461 (Country Downs); then northerly again along the eastern boundary of that native title determination application (and that pastoral lease) to the southernmost point on the southern boundary of Lot 851 DP066631; then northerly along the western boundary of that lot (and again that native title determination application) to the north eastern corner of Native Title Determination Application WAD124/10 Jabirr Jabirr People (WC2010/005); then westerly along the prolongation easterly of the southern boundary of Reserve



22615 and the southern boundary of that reserve to its south western corner; then westerly to the north western corner of Native Title Determination Application WAD124/10 Jabirr Jabirr People (WC2010/005) at Longitude 122.145895° East, Latitude 17.239080° South; then westerly to the 3 nautical mile limit; then northerly to a point again on the 3 nautical mile limit around the Lacepede Islands; then generally north westerly along that 3 nautical mile limit to its westernmost point; then northerly to the prolongation westerly of the northern boundary of Native Title Determination Application WAD68/10 Nyul Nyul (WC2010/003); then easterly along that prolongation to Longitude 122.209680° East, Latitude 16.751355° South (being the north western corner of Native Title Determination WAD68/10 Nyul Nyul (WC2010/003); then east to the westernmost corner of Native Title Determination WAD68/10 Nyul Nyul (WC2010/003); then east to the westernmost corner of Native Title Determination WAD49/98 Bardi and Jawi (WCD2005/003) being a point on the 3 nautical mile limit; then easterly, southerly and again easterly along the boundaries of that native title determination back to the commencement point.
