

The application area covers all the land and waters within the external boundary described as:

Commencing at the northern most north east corner of Native Title Determination WAD6099/1998 Nyikina Mangala (WCD2014/003), being a point on the southern boundary of Reserve 1834 and a southern boundary of native title determination application WAD359/2013 Bindunbur (WC2015/007); then extending easterly along the southern boundary of that native title determination application to the intersection of the western boundary of native title determination application WAD359/2013 Bindunbur (WC2015/007) at Longitude 123.584619° East, Latitude 17.234082° South; then northerly along the western boundary of that native title determination application to the intersection of Longitude 123.584619° East and the south western boundary of native title determination application WAD104/2011 Mawadjala Gadjidgar (WC2011/003) defined by a line joining the intersection of a southern boundary of Pastoral Lease N050375 (Meda) and a north eastern corner of Reserve 51146 with Longitude 123.47829° East, Latitude 17.145141 South; then south easterly along that line to the intersection of a southern boundary of Pastoral Lease N050375 (Meda) and a north eastern corner of Reserve 51146; then generally north easterly, generally south easterly, southerly, easterly, again southerly, again easterly and again southerly along the boundaries of General Lease L245229, Fitzroy Location 228, closed road and Reserve 1326 to the northern boundary of the Derby Gibb River Road; then south easterly along the boundary of that road to the centreline of an unnamed creek at approximately Longitude 123.89597° East; then generally southerly along that centreline to the intersection with a northern boundary of native title determination WAD6099/1998 Nyikina Mangala (WCD2014/003) being a line joining Longitude 123.917953° East, Latitude 17.415266° South and Longitude 123.834621° East, Latitude 17.415267° South; then westerly along that determination to Longitude 123.751288° East, Latitude 17.415267° South; then again westerly along a line joining that previous coordinate point and Longitude 123.667955° East, Latitude 17.415268° South to the High Water Mark (also being a boundary of the Derby Port Area); then generally south westerly and generally northerly, again generally south westerly, again generally northerly, generally easterly and again generally northerly along that determination boundary back to the commencement point.
