# Ngurrara D1



## **External boundary description**

The application area covers all the land and waters within the external boundary described as:

## Area A

That portion of Unallocated Crown Land subject to Petroleum Exploration Permit EP 456 (as at 01 February 2012) that falls within the following area:

All those lands and waters commencing at Longitude 123.501306° East, Latitude 19.331940° South being a point on a southern boundary of Native Title Determination WAD25/2012 Yi-Martuwarra Ngurrara Part A (WCD2018/001) and a western boundary of Native Title Determination WAD6077/1998 Ngurrara Part A (WCD2007/005), and extending southerly along the boundary of that latter native title determination to Longitude 123.501308° East, Latitude 19.831950° South, being a point on the boundary of again Native Title Determination WAD25/2012 Yi-Martuwarra Ngurrara Part A (WCD2018/001); then westerly along that native title determination to Longitude 123.466413° East, Latitude 19.831950° South, being an eastern boundary of Native Title Determination WAD6100/1998 Karajarri People (Area A) (WCD2002/001); then northerly along the boundary of that native title determination to Longitude 19.331942° South, being a point on a boundary of again Native Title Determination WAD25/2012 Yi-Martuwarra Part A (WCD2018/001); then easterly along the boundary of that native title determination back to the commencement point.

## Area B

That portion of Unallocated Crown Land subject to Petroleum Exploration Permit EP 456 (as at 01 February 2012) that falls within the following area:

All those lands and waters commencing at Longitude 123.501309° East, Latitude 19.998619° South being a point on a western boundary of Native Title Determination WAD6077/1998 Ngurrara Part A (WCD2007/005) and extending southerly along that native title determination to Latitude 20.998617° South, being a boundary of Native Title Determination WAD25/2012 Yi-Martuwarra Ngurrara Part A (WCD2018/001), then westerly along that native title determination to intersect with a line drawn between Longitude 123.501315° East, Latitude 20.998619° South and Longitude 123.481307° East, Latitude 20.090213° South; then north westerly onto Longitude 123.481307° East, Latitude 20.090213° South; being a point on the southern boundary of Native Title Determination WAD6100/1998 Karajarri People (Area A) (WCD2002/001); then again



north westerly along that native title determination to Longitude 123.480831° Eat Latitude 20.081953° South, a point again on the boundary of Native Title Determination WAD25/2012 Yi-Martuwarra Ngurrara Part A (WCD2018/001); then easterly and northerly and again easterly along boundaries of that native title determination back to the commencement point.

## Area C

That portion of Unallocated Crown Land subject to EP 417 R1 (as at 01 February 2012) that falls within the following area:

Commencing on the southern boundary of Yougawalla Pastoral Lease (N050502) at Longitude 126.743026° East, being a north western corner of Native Title Determination WAD6077/1998 Ngurrara Part A (WCD2007/005) and extending southerly along the boundary of that native title determination to the northern boundary of Lot 331 on Deposited Plan 55300, being a northern boundary of Native Title Determination WAD25/2012 Yi-Martuwarra Ngurrara Part A (WCD2018/001); then westerly along the boundary of that lot to again the intersection with Native Title Determination WAD6077/1998 Ngurrara Part A (WCD2007/005); then north westerly along that native title determination to the north eastern corner of Reserve 5280; then westerly along the northern boundary of that reserve to the intersection with again Native Title Determination WAD6077/1998 Ngurrara Part A (WCD2007/005) at Longitude 126.663914° East; then north westerly along that boundary to Longitude 126.649631° East, Latitude 20.122745° South, being a point on the boundary of Native Title Determination WAD6077/1998 Ngurrara -Area B (WCD2012/005); then generally north easterly, generally north westerly, along the boundaries of that determination passing through the following coordinate points.

Then westerly along a northern boundary of Native Title Determination WAD6077/1998 Ngurrara -Area B (WCD2012/005) to Longitude 126.417930° East, Latitude 19.863701° South, being a boundary of Native Title Determination WAD25/2012 Yi-Martuwarra Ngurrara Part A (WCD2018/001) and a western boundary of EP 417 R1; then northerly and easterly along the boundary of that native title determination and that exploration permit to intersect with a boundary of Yougawalla Pastoral Lease (N050502) at Latitude 19.665263° South, then southerly and easterly along that pastoral lease back to the commencement point.

## Area D

That portion of Unallocated Crown Land subject to EP 417 R1 (as at 01 February 2012) that falls within the following area:

Commencing on a northern boundary of Reserve 5280 at Longitude 126.417933° East, being a point on the boundary of Native Title Determination WAD25/2012 Yi-Martuwarra Ngurrara Part A (WCD2018/001) and a western boundary of EP 417 R1 and extending northerly, westerly, again northerly and easterly along the boundaries of that native title determination and that exploration permit to the intersection with Native Title Determination WAD6077/1998 Ngurrara - Area B (WCD2012/005) at Longitude 126.411698° East; then generally south easterly, generally southerly and generally south westerly along the boundaries of Native Title Determination WAD6077/1998 Ngurrara - Area B (WCD2012/005) passing through the following coordinate points.
