The application area covers all the land and waters within the external boundary described as:

22.025709° South, being the eastern most point on the boundary of Native Title Determination
Application WAD6287/1998 Palyku (WC1999/016); then generally westerly and generally north
westerly along the northern boundary of Native Title Determination Application WAD6287/1998
Palyku (WC1999/016) passing through the following coordinate points:
