The application area covers all the land and waters within the external boundary described as:

Commencing at a point on a eastern boundary of Area 1 of Native Title Determination WAD72/1998 Nharnuwangga (WCD2000/001) at the southernmost south eastern corner of Reserve 35104 (Collier Range National Park) and extending northerly and generally north easterly along boundaries of that reserve to a western boundary of Native Title Determination WAD6002/2003 Gingirana (WCD2017/011) at Longitude 119.548414° East; then south westerly along that determination boundary to a northern boundary of Reserve 16733 at Longitude 119.539370° East, being the north eastern corner of Area 2 of Native Title Determination WAD72/1998 Nharnuwangga (WCD2000/001); then westerly and southerly along boundaries of Area 2 of that determination to its southern corner on the western boundary of Reserve 16733 at Latitude 24.716361° South, being a point on the eastern boundary of Native Title Determination WAD6002/2003 Gingirana (WCD2017/011); then south westerly along the eastern boundary of that determination to a southern boundary of Kumarina Pastoral Lease (N050094) at Longitude 119.417296° East, being a north eastern corner of Area 1 of Native Title Determination WAD72/1998 Nharnuwangga (WCD2000/001) and then westerly along that determination boundary back to the commencement point.

For the avoidance of any doubt, the application excludes any area subject to:

- Native Title Determination WAD72/1998 Nharnuwangga (WCD2000/001) as determined by the Federal Court on 29 August 2000.
- Native Title Determination WAD6002/2003 Gingirana (WCD2017/011) as determined by the Federal Court on 7 December 2017.
