The area of the agreement is the area of the BPH Petroleum Minerva Gas Development. This comprises one pipe trench or corridor from the Minerva Gas Field, 10km south of Port Campbell National Park in the Two Mile Bay area to a gas plant approximately 4km northwest of Two Mile Bay.

## Statements of the kind mentioned in ss. 24EB(1) or 24EBA(1) or (4)

Framlingham Aboriginal Trust and The Kirrae Whurrong Native Title Group agree and consent under section 24EB (1)(b) of the Native Title Act 1993 (Cth) to:

- A thirty metre wide easement over the route to be followed through the Land by the Pipeline (the 'Pipeline Corridor'), which easement will be an easement over and in respect of the Native Title Rights as they may exist in respect of the Pipeline Corridor.
- The grant, on behalf of the State of Victoria, of a permit under section 12 and a licence under section 25 of the Pipelines Act 1976 (Vic) ("the Act") to allow BHP Petroleum to construct, own and operate the proposed pipeline.
- The grant, on behalf of the State of Victoria, of any easement, licence or authority under section 20(1) of the Act so as to enable BHP Petroleum to construct, operate, inspect, maintain or repair the proposed Pipeline through or over the land.
- The consent on behalf of the State of Victoria, to the commencement of operations of the pipeline under section 35(1A) of the Act.
- Consent to the appropriate Minister or the Governor of the State of Victoria granting an easement over the Pipeline Corridor, a permit to construct and operate the Pipelines and a licence to own and use the Pipelines, despite any impairment of Native Title, or the enjoyment thereof, that may be caused thereby.
