# Statements of the kind mentioned in ss. 24EB(1) or 24EBA(1) or (4)

Clause 1.3

Upon registration of this Agreement, the Native Title Group surrenders to the State any native title rights and interests which they may hold over the ILUA area. This surrender is intended to extinguish any existing native title rights and interests over the ILUA area.

Clause 6.1 The parties agree that the right to negotiate provisions in Part 2, Division 3, Subdivision P of the NTA are not intended to apply to the grant of fee simple title to the proponent over the ILUA area.

### Clause 6.2

Subject to compliance by the parties with the provisions of this agreement, the parties: - agree to the surrender by the Native Title Group to the State of native title rights and interests over the ILUA area

- agree to the grant by the State of fee simple under s.209(2) of the Land Act 1958 to the proponent in respect of the ILUA area; and

- agree that the grant of fee simple title to the proponent in respect of the ILUA area is valid.

Definitions:

'Native Title Group' means the Dhuudhoroa Native Title Group being the persons who claim to hold native title in relation to the land and/or waters in the ILUA area.

'NTA' means the Native Title Act 1993 (Cth).

'Proponent' means each person who, from time to time, holds a legal or beneficial interest in the ILUA Area.

'ILUA area' means the area of land and/or waters covered by this Agreement as described in Schedule C and shown on the map in Schedule C1.

'State' means the State of Victoria and all its instrumentalities.
