Description of the area covered by the agreement

The agreement area is described in the agreement at Clause 2.1:
This Agreement relates to that area of the Determined Area which is the subject of any Tenement application.

'Determined Area' is defined at clause 1.1 (3) as 'any area in relation to which the native title party is the registered native title body corporate'.

'Tenement' is defined in clause 1.1 (8) as 'any mining tenement to be granted under the Mining Act 1978 (WA) pursuant to any application described in the schedule'.

A copy of the schedule (referred to above in the definition of 'Tenement') is attached to the Register Extract as Attachment A.

A map of the area subject to the agreement is attached to the Register Extract as Attachment B.

The following general description of the agreement area has also been provided by the National Native Title Tribunal to assist people to understand the location of the agreement area. It does not replace, and is less precise than, the description of the agreement area contained in the agreement. It is provided for information only and should not be considered part of the Register of ILUAs:

The agreement area comprises 4 tenement applications covering approximately 68 square kilometres and is located approximately 180km south east of Karratha located between Mt Margaret and Hamersley homestead. The agreement falls within the Local Government Authority of the Shire of Ashburton.

6. STATEMENTS FOR PURPOSES OF S24EB(1)(B) OF THE NTA
