The Agreement Area covers all the lands and waters the subject of the following mining tenement applications to the extent such land and waters coincide with the area described in the First Schedule of the Thalanyji Determination (WAD 6113 of 1998), excluding those portions of land and waters identified and described in the Second Schedule of that Determination.

The area subject to this agreement covers about 5 square kilometres and consists of 10 mining tenements, located south of Onslow. The area falls entirely within the determination of native title for Thalanyji (WAD6113/1998) as determined on 18 September 2008 as shown on the locality map. The agreement area falls within the Local Government Authority of the Shire of Ashburton.
