Description of the area covered by the agreement

Agreement area is defined in clause 1 of the agreement as the area shown and described in the map in Schedule 1. A copy of Schedule 1 is attached to this register extract.

The following general description of the agreement area has been provided by the National Native Title Tribunal to assist people to understand the location of the agreement area. It is provided for information only and should not be considered part of the Register of ILUAs:

The area subject to this agreement covers about 142 square kilometres and is located approximately 30 kilometres north west of Newman. The agreement falls within the Local Government Authority of Shire of East Pilbara.

Clause 10 Term of this document

10.1 Commencement and termination

This document commences on the Commencement Date and terminates on a date agreed in writing by the parties.

Commencement Date is defined as 'the date inserted above the parties' names on page 1 of the body of this document or where no date has been inserted or the date inserted is manifestly wrong, the date on which this document is taken to have been signed by the last person required to do so'.

Statements of the kind mentioned in ss. 24EB(1) or 24EBA(1) or (4)

Clause 8.5 For the purposes of section 24EB(1) of the Native Title Act, the parties consent to all Agreed Future Acts without conditions but in accordance with this document.

Clause 8.6 The parties agree that the process set out in Subdivision P of Division 3 of Part 2 of the Native Title Act, known as the "right to negotiate" process is not intended to apply to the Agreed Future Acts.

Agreed Future Acts means each Future Act required for the Grant of a lease to the HDJV [Hope Downs Joint Venturers] under section 79 of the Land Administration Act 1997 (WA) in relation to any parts of the Agreement Area for the purpose of constructing, operating and maintaining a railway, power line, access road and all associated and incidental infrastructure and facilities.
