Description of the area covered by the agreement

4.1 The Licence areas are the areas of land and/or waters covered by the Agreement as described in Schedule C and shown on the map in Schedule C1 [the map of the agreement area at Schedule C1 is attached to this register entry].

Schedule C: The Licence area is all of the land and waters subject to Exploration Licence Applications 4214 and 4541. Exploration Licence 4214 is located 20 km west of Maryborough and covers an area of approximately 827 km2. Exploration Licence 4541 is located 2 km southease of Tarnagulla and covers an area of approximately 8 km2.

[The following general description of the agreement area has been provided by the National Native Title Tribunal to assist people to understand the location of the agreement area. It is provided for information only and should not be considered part of the Register of ILUAs:

The NNTT's Geospatial Services unit has found that the correct size and location of the agreement area (areas subject to Exploration Licence Applications 4214 and 4541) is approximately 187 square km, located approximately 7km southwest of Bridgewater.]

- agree to the grant by the State of the Licences to the proponent and to any consent required by or on behalf of the proponent pursuant to the Licences in respect of the Licence areas; and
- agree to the use of the Licences and of any consent required pursuant to the Licences, by the proponent in respect of the Licence areas; and
- agree that any such exploration done in respect of the Licence areas is valid.
