Description of the area covered by the agreement

1.1 'Agreement Area' means that part of the Lease Area which is contained within the external boundaries of the Claim Area in the Native Title Claim, and which is described in Schedule 3 to this Agreement.

'Claim Area' means the land and waters the subject of Federal Court Proceedings QUD 189 of 2010.

[A map and description of the agreement area is contained in Schedule 3 of the agreement. A copy of Schedule 3 is attached to this register extract.

The following general description of the agreement area has been provided by the National Native Title Tribunal to assist people to understand the location of the agreement area. It is provided for information only and should not be considered part of the Register of ILUAs:

The agreement covers about 900 sq km over Lot 4596 on PH26 (Digby Peaks Pastoral Lease), Lot 3562 on SP261206 (Willsdown Pastoral Lease) and Lot 4174 on PH45 (Corrie Downs Pastoral Lease) approximately 15 kilometres south-west of Chatsworth].
