ILUA Area means, the area to which this Agreement applies, being the land as described in Schedule 1 ("Description of ILUA Area") and shown in the map in Schedule 2 ("Map of ILUA Area").

2 Commencement

(a) This Agreement commences on the Commencement Date and operates for the duration of the Project unless terminated earlier.

Commencement Date means the date this Agreement is executed by the last of the Parties to execute it.

5 Statement for the purpose of the NTA

For the purposes of:

- (a) section 24EB(1)(c) of the NTA; and
 - (b) regulation 7(5)(b) of the ILUA Regulations,
- the Parties agree that Subdivision P, Division 3, Part 2 of the NTA is not intended to apply to the Agreed Acts.

8.1 Project and associated Project rights

- (a) The Parties consent and agree to the doing of the Agreed Acts and the validation of the Prior Acts.

Agreed Acts means

- (a) the grant of the Project Rights; and
 - (b) all acts necessary or expedient for, in connection with or in relation to, or ancillary or incidental to the Project, including all activities conducted or authorised under any Project Right; and
 - (c) the Prior Acts,
- to the extent that such matters constitute or amount to Future Acts, whether on or after the Commencement Date.

Powerline means the proposed high voltage electricity transmission line and associated assets used to transport electricity from the site of the Owen Springs Power Station to the site of the substation adjacent to the Joint Defence Facility Pine Gap site and all associated facilities.

Prior Acts means those matters the subject of paragraph (a) or (b) of the definition of Agreed Acts that were done prior to the Registration Date.

Project means all activities, works and operations to develop, construct, install, use, operate, maintain, repair, replace and further develop the Powerline in the ILUA Area, including the Powerline, a substation, laydown areas, temporary construction huts and access roads.

Project Rights means all approvals, authorisations, authorities, certificates, consents, declarations, directions, easements, leases, licences, notices, permits, renewals, rights, tenures or titles:

- (a) from any Government Agency; and
- (b) for the carrying out of the Project in the ILUA Area.
