## Description of the area covered by the agreement

### 3. Relevant area for this Agreement

#### 3.1 Relevant area

This Agreement applies to the ILUA Area.

#### 3.2 Inconsistency in description and map

If there is an inconsistency between the description of the ILUA Area in Schedule 1 and the map in Schedule 2, the ILUA Area as defined by the description in Schedule 1 prevails.

**ILUA Area** means the area to which this Agreement applies, being the land or waters as described in Schedule 1 and shown in the map in Schedule 2.

[A copy of Schedules 1 and 2 are attached to this Register extract. The following general description of the agreement area has been provided by the National Native Title Tribunal to assist people to understand the location of the agreement area. It is provided for information only and should not be considered part of the Register of ILUAs:

*The agreement area consists of two separate areas, with a combined area of about 0.27 sq km, located about 80 km and 105 km north east of Camooweal respectively]*

## 2. Commencement

This Agreement commences on the Commencement Date.

**Commencement Date** means the date this Agreement is executed by the last of the Parties to execute it.

## 5. Statement for the purpose of the NTA

For the purposes of:

- (a) section 24EB(1)(c) of the NTA; and
- (b) regulation 6(5)(b) of the ILUA Regulations,

the Parties agree that Subdivision P of Division 3 of Part 2 of the NTA is not intended to apply to the Agreed Act.

## 9. Consent and agreement

### 9.1 Agreed Acts

The Parties consent to the Agreed Acts.

**Agreed Acts** means any or all of the following:

- (a) the amendment, extension, renewal or variation of a Relevant Sales Permit that is in force on the Execution Date;
  - (b) the grant of a Relevant Sales Permit on or after the Execution Date;
  - (c) the amendment, extension, renewal or variation of a Relevant Sales Permit that is granted on or after the Execution Date,
- and, to avoid doubt, includes a Relevant Amendment of a Relevant Sales Permit; "**Get**", in relation to Quarry Material has the meaning given in the *Forestry Act 1959* (Qld).

**ILUA Regulations** means the *Native Title (Indigenous Land Use Agreement) Regulations 1999* (Cth).

**NTA** means the *Native Title Act 1993* (Cth).

**Relevant Amendment** of a Relevant Sales Permit, means an amendment, variation, extension or renewal of the Relevant Sales Permit that relates to:

- (a) an area to which the Relevant Sales Permit applies that is within the ILUA Area;
- (b) the expiry date of the Relevant Sales Permit;
- (c) the scope of activities authorised by the Relevant Sales Permit for the purpose of Getting Quarry Material from within the ILUA Area; and
- (d) the type or quantity of Quarry Material authorised to be Got under the Relevant Sales Permit from within the ILUA Area.

**Relevant Sales Permit** means:

- (a) a sales permit granted or issued under the *Forestry Act 1959* (Qld), sections 46 and 56, to Myuma that authorises Myuma to Get Quarry Material from within the ILUA Area; and
- (b) includes Sales Permit 201509026 to the extent it applies to the ILUA Area.

**Sales Permit 201509026** means the *Forestry Act 1959* (Qld) sales permit 201509026 contained in Schedule 3, as amended or varied from time to time.
