## Description of the area covered by the agreement

Schedule 1 of the agreement describes the Agreement area as all the land and waters within that part of Lot 5203 on PH1063 (Lamonds Lagoon Pastoral Holding).

The Agreement commences on the date of the determination by the Federal Court in favour of the Warrungu People, being 23 September 2013.

5.4 In the event a Determination recognising the right to possession and occupation of the Agreement Area, to the exclusion of all others, is made to:

- (a) persons other than the Warrungu People, the Agreement terminates as at the date of the Determination; or
- (b) the Warrungu People, the Agreement continues unless otherwise determined by the Warrungu People.

5.5 Unless otherwise agreed, this Agreement will end with the valid extinguishment of Native Title over the whole of the Agreement Area.
