17.1 The term of this Agreement commences on the Commencement Date.

17.2 Except for the obligations arising under clause 17 below and obligations accrued before termination, this Agreement will come to an end and the Parties will be released from further compliance with its terms:(a) when the Pastoral Lease comes to an end; or(b) by the written mutual agreement of all the Parties, whichever happens first.

"Commencement Date" means:

(a) to the extent that this Agreement has force as a contract, the date on which this agreement has been executed by all of the parties to it; and

(b) to the extent that this Agreement has force as an Indigenous Land Use Agreement, upon its Registration as an Indigenous Land Use Agreement.

"Party" means a party to this Agreement.

"Pastoral Lease" means Pastoral Lease N 049681 being Christmas Creek Station and any extension of the term, renewal or re-grant of that pastoral lease made at any time during the term of this Agreement.
