# Description of the area covered by the agreement

## 3.8 Area to which this Agreement applies

This Agreement applies to the land and waters the subject of the Wanggil claim.

**Agreement Area** means the land and waters described in Schedule 1 to this Agreement and depicted on the maps annexed to Schedule 1.

**Wanggil Claim** means the native title determination application with Federal Court file number WAD274/2019 filed in the Federal Court on 10 May 2019.

The following general description of the agreement area has been provided by the National Native Title Tribunal to assist people to understand the location of the agreement area. It is provided for information only and should not be considered part of the Register of ILUAs:

The application area covers all of Lot 525 on Deposited Plan 409302, being an area of approx. 1.66 sq km, located approx. 6.5 km southwest of the Gibb River Road/Great Northern Highway intersection and approx. 14 km east of the Emma Gorge Resort.]

#### 2.1 Commencement

This Agreement commences on the Execution Date and binds each of the Parties, their successors and permitted assigns.

#### 2.3 Agreement to Terminate

If all Parties agree in writing, the Parties may terminate this Agreement at any time, including at any time after this Agreement is registered on the ILUA Register.

Execution Date means the date of execution of this Agreement by the last of the Parties to execute it.

**ILUA Register** means the Register of Indigenous Land Use Agreements established under section 199A of the NTA.

**Registered** means registered, pursuant to Part 2, Division 3, Subdivision C of the NTA, on the Register of Indigenous Land Use Agreements established under section 199A of the NTA, and both Register and Registration have a corresponding meaning.

#### 3.3 Consent to Future Act

Subject to this Agreement, each Party consents to the amendment of the boundaries of Reserve 40419 for the purpose of "Gravel (Main Roads)" to include Lot 525 on Deposited Plan 409302 under section 51 of the *Land Administration Act 1997* (WA) with the intent that such statement of consent satisfies the requirement of section 24EB(1)(b) of the NTA in respect of that act.

For the avoidance of doubt consent to the Land Transaction includes agreement, and consent to, the exercise of any right or obligation created by the Land Transaction on the person on whom the right or obligation is, or was, conferred.

## 3.5 No Right to Negotiate

(a) The Right to Negotiate Procedure does not apply to the Land Transaction, with the intent that such statement satisfies the requirement of section 24EB(1)(c) of the NTA.

Land Transaction means the amendment of the boundaries of Reserve 40419 for the purpose of "Gravel (Main Roads)" to include Lot 525 on Deposited Plan 409302 under section 51 of the Land Administration Act 1997 (WA).

NTA means the Native Title Act 1993 (Cth).

Right to Negotiate Procedure means the procedure under Subdivision P of Division 3 of Part 2 of the NTA.
