MATTERS DETERMINED:

THE COURT DETERMINES THAT:

1. Pursuant to s225 of the *Native Title Act 1993* (Cth), native title does not exist in relation to all of the land and waters comprised in the parcels of freehold land described in Schedule 1, excluding any part of such land and waters that is covered by the areas described in Schedule 2 and depicted in the map in Schedule 3.

THE COURT ORDERS THAT:

2. The proceeding be otherwise dismissed without prejudice to any right of the native title claim group members by an authorised applicant (other than a member of the present applicant) to make a claimant application in relation to the areas described in Schedule 2 to the extent that those areas are claimable at the date when any such claimant application might be made.
