Native title does not exist in relation to any part of the land or waters within the external boundary of proceeding QUD 25 of 2019 which, for the avoidance of doubt, is as described below per Attachment B of the current Form 1 filed on 20 February 2020. Attachment C of the current Form 1 filed on 20 February 2020 is reproduced at the end of that description:

External Boundary

The application area is bounded in the north by the Gurang Land Council Aboriginal Corporation Representative Aboriginal/Torres Strait Islander Body (RATSIB) area boundary and native title determination application QG6230/98 Jangga People (QC98/10), in the east by native title determination applications Q6023/01 Barada Barna Kabalbara & Yetimarla People #4 (QC01/25) and QG6195/98 Kangoulu People (QC98/25), in the south by native title determination application QG6156/98 Bidjara #3 (QC97/49), and in the west by the Great Dividing Range.

This application does not overlap existing native title determination applications listed above as at December 2003.

The application is further described as commencing at a point on the northern boundary of the Gurang Land Council Aboriginal Corporation RATSIB area where it intersects native title determination application QG6230/98 Jangga People (QC98/10) at Latitude 21.633116° South, and extending generally south easterly, generally easterly and generally north easterly along the southern boundaries of that application as described by the following coordinates;

Then north westerly to the eastern boundary of the Jericho-Dunrobin Road reserve at Latitude 22.965294° South; then generally northerly along the eastern boundaries of that road reserve, the Dunrobin-Lou Lou Park Road reserve, the Shuttleworth-Carmichael Road reserve and the Moray-Carmichael Road reserve to intersect a northern boundary of the Gurang Land Council Aboriginal Corporation RATSIB area; then easterly, generally northerly, generally easterly and generally south easterly along that RATSIB boundary back to the commencement point.
