SCHEDULE 1 – Determination Area

The Determination Area is located wholly within and comprises all land and waters bounded by the following line:

Then west in a straight line to its intersection with the eastern boundary of the suburb of Port Augusta West then generally south-easterly and generally south-westerly along the eastern boundary of the suburb of Port Augusta West to the point of commencement.
