9. Access to Mining and Petroleum Areas

- (a) Without limiting the operation of any other clause in Schedule Six and subject to the operation of the *Aboriginal Affairs Planning Authority Act 1972* (WA) and the *Aboriginal Affairs Planning Authority Regulations 1972* (WA), any rights of the holders from time to time of the mining or petroleum interests listed in clauses 7 and 8 of this Schedule Six to use (including by servants, agents and contractors) such portions of existing roads and tracks in the Determination Area as are necessary to have access to the area the subject of the mining or petroleum interest for the purposes of exercising the rights granted by that interest.

- (b) Nothing in Schedule Six will limit the rights of the holders from time to time of mining or petroleum interests referred to in clauses 7 and 8 of this Schedule Six, including, without limitation, any right to exclude members of the public from entering onto the land and waters the subject of any mining or petroleum interest.

10. Telstra Corporation Limited

The rights and interests of Telstra Corporation Limited (ACN 051 775 556):

- (a) as the owner or operator of telecommunications facilities within the Determination Area;
- (b) created pursuant to the *Post and Telegraph Act 1901* (Cth), the *Telecommunications Act 1975* (Cth), the *Australian Telecommunications Corporation Act 1989* (Cth), the *Telecommunications Act 1991* (Cth) and the *Telecommunications Act 1997* (Cth), including rights:
 - (i) to inspect land;
 - (ii) to install, occupy and operate telecommunications facilities; and
 - (iii) to alter, remove, replace, maintain, repair and ensure the proper functioning of its telecommunications facilities;
- (c) for its employees, agents or contractors to access its telecommunications facilities in, and in the vicinity of, the Determination Area in performance of their duties; and
- (d) under any lease, licence, permit, access agreement or easement relating to its telecommunications facilities in the Determination Area.

11. Woodstock and Abydos Protected Area

The rights and interests comprised in, conferred under or in accordance with, or pursuant to the Woodstock and Abydos protected area declared pursuant to s 19 of the *Aboriginal Heritage Act 1972* (WA) by Order in Council published in the Government Gazette on 25 May 1979 (as amended by notice published in the Government Gazette on 18 July 2006).

12. Indigenous Land Use Agreement

The *Kariyarra and State ILUA* made pursuant to Pt 2, Div 3, Subdiv C of the *Native Title Act* and registered as an Indigenous Land Use Agreement on 29 May 2018 (NNTT Number

WI2017/016) and the rights and interests comprised in, conferred under or in accordance with, or pursuant to, that Indigenous Land Use Agreement.

13. Other

The following rights and interests in the Determination Area:

- (a) Rights and interests, including licences and permits, validly granted (including in accordance with the *Native Title Act*) by the Crown in right of the State or of the Commonwealth pursuant to statute or otherwise in the exercise of its executive power and any regulations made pursuant to such statutes;
- (b) Rights and interests held by reason of the force and operation of the laws of the State or of the Commonwealth including, but not limited to, the *Rights in Water and Irrigation Act 1914* (WA) and which validly affect native title;
- (c) The rights and interests of members of the public arising under the common law, including but not limited to:
 - (i) the public right to fish;
 - (ii) the public right to navigate; and
 - (iii) the right of any person to use and enjoy any roads in the Determination Area (subject to the laws of the State) over which, as at the date of this determination, members of the public have a right of access under the common law;
- (d) The right to access the Determination Area by:
 - (i) an employee, agent or instrumentality of the State;
 - (ii) an employee, agent or instrumentality of the Commonwealth; or
 - (iii) an employee, agent or instrumentality of any local government authority,as required in the performance of his or her statutory or common law duty where such access would be permitted to private land;
- (e) So far as confirmed pursuant to s 212(2) of the *Native Title Act* and s 14 of the *Titles Validation Act* as at the date of this determination, any existing public access to and enjoyment of:
 - (i) waterways;

- (ii) beds and banks or foreshores of waterways;
 - (iii) coastal waters;
 - (iv) beaches;
 - (v) stock routes; and
 - (vi) areas that were public places at the end of 31 December 1993; and
- (f) Any other validly granted or created (including in accordance with the *Native Title Act*):
- (i) legal or equitable estate or interest in the land or waters of the Determination Area; or
 - (ii) right (including a right under an option and a right of redemption), charge, power or privilege over, or in connection with:
 - (A) the land or waters of the Determination Area; or
 - (B) an estate or interest in the land or waters of the Determination Area; or
 - (iii) restriction on the use of the land or waters of the Determination Area, whether or not annexed to other land or waters.
