

QUD277/2019 Wakka Wakka People #4 (QC2012/003) – Remaining application area

This description is an interpretation of the application area that remains undetermined following the determination of native title by the Federal Court of Australia for QUD277/2019 - Wakka Wakka People #4 – Part A (QCD2022/004) on 12 April 2022 and QUD277/2019 - Wakka Wakka People #4 – Part B (QCD2023/009) on 21 September 2023.
