



QUD 28/2019 - Wadja People

External Boundary Description (November 2022)

This application does not include any area that have not been previously claim by the application.

The remaining application area covers all the land and waters within the external boundary described as:

Commencing at the intersection of the northern boundary of Native Title Determination QUD6162/1998 Iman People 2 (QCD2016/005) and the eastern boundary of Lot 16 on SP228375 (Bedourie) at Latitude 24.998406° South, a point on the ridgeline of Expedition Range and extending generally northerly along that ridgeline, further described as generally northerly along eastern boundary of Lot 16 on SP228375 (Bedourie) to the southern boundary the Parish of Fairfield at Latitude 24.877877° South; then generally north westerly along the southern boundary of that parish to the eastern boundary of Lot 1 on CUE95 (Deep Creek Holding); then generally northerly along eastern boundaries of that lot, western boundaries of Lot 47 on FTY1838 (Mount Nicholson State Forest), Lot N on SP142673, Lot A on BH298, Lot C on WNA154, Lot B on WNA155, Lot 2 on WNA124 to its intersection with the southern boundary of Native Title Determination Application QUD33/2019 Gaangalu Nation (QC2012/009) at Latitude 24.235079° South, being a line extending from the junction of an unnamed creek and Planet Creek at Latitude 24.228227° South to the source of Taylors Creek at Longitude 149.069991° East, Latitude 24.246565° South; then south easterly to the source of Taylors Creek; then generally easterly and generally south easterly along the centrelines of that creek, Spring Creek and Mimosa Creek to Longitude 149.790582° East; then south easterly to the northern boundary of northern severance of Lot 30 on FTY642 (Roundstone State Forest) at Longitude 149.790669° East; then generally north easterly, generally south easterly and generally southerly along the northern and eastern boundaries of that lot to the eastern boundary of Lot 13 on BH314, also being the ridgeline of Dawson Range; then generally south easterly along that range, further described as generally south easterly along the eastern boundaries of Lot 13 on BH314, Lot 9 on BH170, Lot 20 on SP289421, Lot 20 on BH150, Lot 21 on BH148, Lot 25 on BH95, Lot 70 on LE275 and Lot 4 on LE221 to Latitude 24.992275° South; then generally westerly to a point on a line of the 320m contour elevation at Longitude 149.759470° East, Latitude 24.996353° South, passing though the following coordinate points:

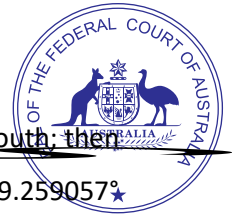

Then generally north westerly along that 320m contour to Longitude 149.669127° East, Latitude 24.941943° South; then generally north westerly to a point on a line of the 230m contour elevation at Longitude 149.664138° East, Latitude 24.934489° South, passing though Longitude 149.665533° East, Latitude 24.938731° South; then generally westerly and generally north easterly along that 230m contour to Longitude 149.660833° East, Latitude 24.924433° South; then generally north westerly to a point on a line of the 320m contour elevation at Longitude 149.643364° East, Latitude 24.903728° South, passing though the following coordinate points:

a line of the 320m contour elevation at Longitude 149.355835° East, Latitude 24.943402° South; then generally westerly and generally south westerly along that 320m contour to Longitude 149.259057° East, Latitude 24.990042° South; then generally westerly passing through the following coordinate points back to the commencement point:
