The amended application area does not include any land or waters not previously claimed.

External Boundary description

All the land and waters within the area described as:

Commencing at a point on centreline of Fitzroy River at Longitude 150.000839° East, a point on the external boundary of Native Title Determination QUD6131/98 Darumbal People (Part A) and extending generally westerly along external boundaries of that determination to Longitude 149.857870° East, a point on the eastern boundary of Native Title Determination Application QUD13/2019 Barada Kabalbara Yetimarala People, further described as:

Extending generally westerly along the centreline of the Fitzroy River to Longitude 149.880542° East; then westerly to the centreline of a watercourse at Longitude 149.857870° East, Latitude 23.079640° South, again a point on the external boundary of Native Title Determination QUD6131/98 Darumbal People (Part A) and a point on the eastern boundary of Native Title Determination Application QUD13/2019 Barada Kabalbara Yetimarala People.

Then generally north-easterly and generally north-westerly along boundaries of Native Title Determination Application QUD13/2019 Barada Kabalbara Yetimarala People to Latitude 22.648881° South, further described as:

Generally north-easterly along the centreline of the watercourse to longitude 149.862210 and generally north-westerly passing through the following coordinate points.
